The specification for additional padding in the yoke area of the jacket was inadvertently left off the bid document and discovered during the review of the product prior to award recommendation. This error will be corrected in the specifications for future bids.

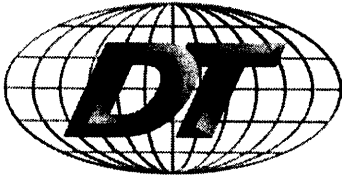
