RESOLUTION NO. 19-023

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT BETWEEN THE GALVESTON COUNTY HEALTH DISTRICT AND THE CITY OF TEXAS CITY, TEXAS, FOR STORAGE OF AN AIR MONITOR AT TEXAS CITY FIRE STATION THREE (3); AND PROVIDING THAT THIS RESOLUTION SHALL BECOME EFFECTIVE FROM AND AFTER ITS PASSAGE AND ADOPTION.

WHEREAS, the Galveston County Health District desires to store a spare air monitor at Fire Station Three (3) located at 1101 N. Amburn Road, Texas City, Texas 77591; and

WHEREAS, the City and its Fire Department is agreeable to provide space at Fire Station Three for storage of the air monitor; and

WHEREAS, the Galveston County Health District and the City of Texas City desire a formal agreement with each other for this purpose.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF TEXAS CITY, TEXAS:

SECTION 1: That the City Commission of the City of Texas City, Texas hereby approves the Memorandum of Agreement between the Galveston County Health District and the City of Texas City, Texas.

SECTION 2: That the Mayor is authorized to execute the Memorandum of Agreement, in the same or similar format attached hereto as **Exhibit "A"** and made a part hereof.

SECTION 2: That this Resolution shall be in full force and effect from and after its passage and adoption.

MEMORANDUM OF AGREEMENT

This is an Agreement by and between Galveston County Health District, (GCHD), and the City of Texas City. For the purpose of this Agreement, GCHD and the City of Texas City are sometimes referred to individually as a "Party" or together as "Parties."

I. PURPOSE & SCOPE

The intention of this Agreement is to clearly identify the means by which the City of Texas City has graciously allowed the storage of a whole air monitor entrusted to GCHD on property owned by the City of Texas City known as Fire Station #3 located at 1101 N. Amburn Rd., Texas City, Texas 77591.

II. PARTIES

GCHD is located at 9850-A Emmett F. Lowry Expressway, Texas City, Texas 77590. The City of Texas City is located at 1801 9th Avenue North, Texas City, Texas 77592.

III. GCHD'S RESPONSIBILITIES

In accordance with this agreement, GCHD agrees to assume the following responsibilities:

1. Store the whole air monitor at a location mutually agreed upon by both parties.
2. Secure the whole air monitor within the confines of the Fire Station #3.
3. If possible, remove the whole air monitor prior in the event of a natural disaster.
4. Communicate with city and fire department officials any issues, operational or safety related.

IV. CITY OF TEXAS CITY RESPONSIBILITIES

In accordance with this Agreement, the City of Texas City agrees to assume the following responsibilities:

1. Provide a safe and secure site for the whole air monitor.
2. Provide access to GCHD whole air monitor, 24/7, 365 days per year.
3. Notify GCHD in the event that the air monitor needs moved or changed location.
4. Refrain from moving the air monitor once stored.

V. MUTUAL COVENANTS

1. Modification Clause: This Agreement may be modified by written amendment, so long as the amendment is consented to and signed by both parties.
2. Term and Termination: This Agreement shall commence at the time in which it is executed by the second signatory and will end upon a written notification being sent by either party to the counterparty at least thirty (30) days in advance. Termination of this Agreement can be made for any reason; with or without cause.

3. Notice: Any notice required to be given pursuant to the terms and provisions of this Agreement shall be set forth in writing and mailed by certified or registered mail to the applicable address set forth below:

VI. INDEMINIFICATION

Parties agree, to the extent permitted by the Constitution and laws of the State of Texas, to indemnify and hold the other party, its officers, employees and agents and their officers, employees and agents (the indemnified parties) harmless from and indemnify each against any and all liabilities, actions, damages, suits, proceedings, judgments and costs (including attorney's fees) for claims resulting from the acts or omissions of the other party or the acts or omissions of others under the party's supervision and control. Furthermore, GCHD covenants and agrees that under no circumstance shall the City of Texas City and/or The Texas City Fire Department be held liable or responsible for any damage(s) to the whole air monitor during the term of this Agreement except in the case of any willful misconduct or gross negligence on the part of The City of Texas City or The Texas City Fire Department. The indemnity contained herein shall survive the termination of this Agreement for any reason whatsoever.

VII. EFFECTIVE DATE AND SIGNATURE

This Agreement shall be deemed effective and enforceable at the time in which it is duly executed. By signing below, GCHD and the City of Texas City indicate their respective intents to agree to the terms and condition set forth herein.

ACTION REQUEST (Brief Summary)

Consider and take action on Resolution No. 19-024, approving the purchase of a 2019 Ford E-450 Chassis, 25' Allstar 20 passenger bus with 2 wheelchairs for the Nessler Senior Program- through HGAC- Houston Galveston Area Council- Buying Cooperative Agreement, Contract No. BT01-19.

BACKGROUND

The bus will replace the existing 2004 passenger bus that has been in and out of the shop for major ongoing repairs that have been costly. We will replace it with a 2019 passenger bus that comes with a 5-year 100,000-mile warranty. Transportation is a vital part of the Nessler Senior Program that is utilized to transport seniors on a daily basis.

ANALYSIS

It is the recommendation of the Recreation and Tourism Department to award the HGAC – Houston Galveston Area Council – Buying Cooperative Agreement, purchase totaling \$69,639.63. Funds are available in the FY 2018/2019 Recreation and Tourism Capitol Equipment replacement fund.

WHEREAS, the Recreation and Tourism Department requests approval for the purchase of a 2019 Ford E-450 Chassis, 25' Allstar 20 passenger bus through H-GAC (Houston-Galveston Area Council), A Buying Cooperative Agreement, Contract No. BT01-19; and

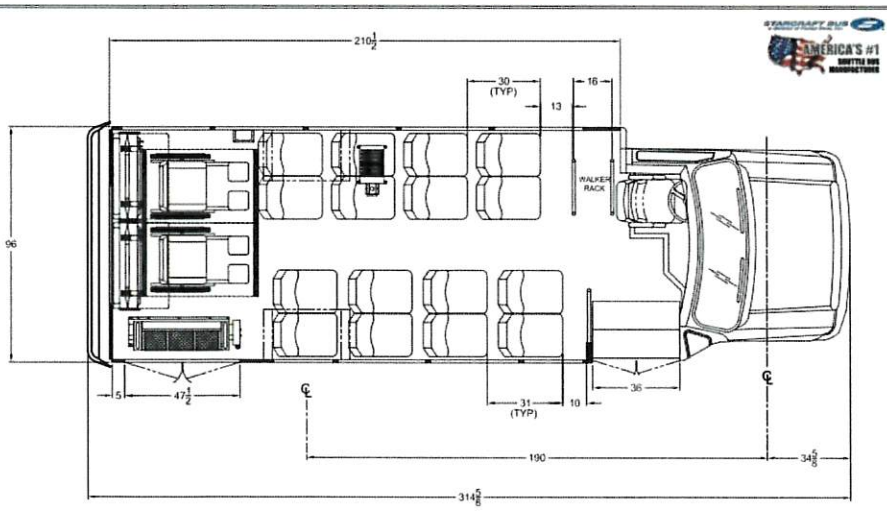

Notice

Please return the warranty registration card to register the warranty with Starcraft Bus so that Starcraft Bus may record your rights under this limited warranty and to ensure prompt assistance. Your dealer will provide the warranty card for you to sign. If you did not sign a Starcraft Bus warranty card at the time of delivery, please contact your dealer.

Definition of Terms

Authorized Starcraft Bus Dealer ("Dealer"): This agreement is applicable only in the United States, Puerto Rico and Canada. Any Authorized Dealer of the owner's choice may perform warranty service work under the Starcraft Bus Warranty Agreement. This vehicle should be delivered to the authorized dealer during normal service hours. A reasonable time should be allowed after taking the vehicle to the authorized dealer for performance of the repair.

Starcraft Bus, Division of Forest River, Inc. ("Warrantor"): The party obligated to perform under this Agreement.

Original Purchaser: Person or entity that is a recipient of this product provided by a dealer under a purchase order or contract sales.

Wear and Tear: The deterioration of a part or material beyond the manufacturer's specified tolerances that occur naturally over time and under normal operating conditions.

1. Who Warrants The Product

The product, as described and limited here, is warranted by the manufacturer and installer of the body: Starcraft Bus, Division of Forest River, Inc., hereinafter referred to as Starcraft Bus, 2367 Century Drive, Goshen, IN; an Indiana Corporation; and is administered by the Starcraft Bus Customer Service Department, Goshen, Indiana 46528.

2. Who Is Covered

Starcraft Bus, the warrantor, extends this limited warranty agreement to the original owner only of the vehicle during the Warranty Period.

3. What Is Covered

Starcraft Bus, your warrantor, extends the following limited warranty to you; in which the limited warranty covers your conversion only pertaining to material defects in all materials and workmanship supplied by or performed by Starcraft Bus.

4. Warranty Period

The Starcraft Bus limited warranty is for a period of five (5) years from the date of first delivery or 100,000 miles, whichever occurs first, except for other coverages listed under "Other Warranties That May Apply" and items listed under "Exclusions and Limitations" and "Limits of the Warranty."

5. Exterior Paint

Exterior Paint, performed by Starcraft Bus, is fully warranted to be free of substantial defects in workmanship by Starcraft Bus for the first three (3) years (50,000 miles) from date of original purchase, 50% warranted four (4) years (75,000 miles), and 25% warranted five (5) years (100,000 miles) from date of original purchase.

6. Other Warranties That May Apply

Starcraft Bus does not warrant the base chassis itself. The vehicle engine, chassis, drive-train, suspension system, battery and other chassis components are covered by a separate warranty offered by the manufacturer of the chassis and administered by the chassis manufacturer's authorized dealers. The tire manufacturer separately warrants tires. In addition, all aftermarket springs, suspensions, driveline retarders, etc., such as Liquid Springs, Mor Ryde, Kelderman, Telma, etc. are not covered by Starcraft Bus. These items are covered by their original manufacturer and their warranties may vary.

7. Owner's Responsibility

Proper preventative maintenance of the exterior and interior of the vehicle is the responsibility of the owner. See the owner's manual(s) for proper care instructions. Defects or damage as a result of improper care or maintenance are not covered by this warranty agreement.

8. Exclusions and Limitations

Damage caused by abuse, misuse, failure to observe reasonable required maintenance practices, acid rain, accidents, natural disasters, acts of war, facing of fabrics, carpeting and/or fiberglass are not covered. Light bulbs and fuses are not covered.

Damage to the unit if such damage is the result of deterioration due to normal use, wear and tear, or exposure to the elements.

Damages that may occur to the chassis, frame, other parts or components that occur due to overloading will not be covered and may invalidate portions of the Starcraft Bus warranty agreement.

Cosmetic or surface corrosion resulting from stone chips or scratches in paint are not covered.

Replacement parts provided under terms of the warranty agreement will whenever possible, match original equipment. When necessary, Starcraft Bus will substitute parts of comparable function and value. Defective items may be replaced with new, remanufactured, reconditioned or repaired components.

Modifications, alterations or repairs performed by unauthorized personnel may invalidate portions of the Starcraft Bus warranty. In addition, using the vehicle to tow another vehicle is prohibited and may void warranty. Contact Starcraft Bus Customer Service before you make modifications, alteration or repairs.

9. Recovery Limitations

No person shall be entitled to recover from warrantor for any consequential or incidental damages arising out of or relating to any defect in the product. These limitations include but are not limited to, loss of time; loss of use; loss of revenues, salaries or commissions; towing charges; bus fares; bus rentals; car rentals; gasoline expenses; telephone charges; inconvenience or other incidental damages.

10. How To Get Warranty Service

To obtain warranty service, contact or visit the dealership where you originally purchased your vehicle or another warranty service facility designated by Starcraft Bus. The dealership must contact Starcraft Bus Customer Service Department for authorization to have a warranty claim submitted. If you or your dealer has moved, or if your dealer is no longer in business, contact Starcraft Bus Customer Service Department (see address and telephone numbers below) for the name of a Starcraft Bus dealer nearest to you. Your claim must be made within 14 days of the discovery of the defect. Starcraft Bus will determine authorization based on and subject to the terms of the warranty agreement. BACKGROUND

CenterPoint Gas has made an Interim Rate Adjustment or “GRIP” filings with the cities in their Houston and Texas Coast divisions. For cities in the Houston Division, the Company is seeking recovery of \$99,461,495 in invested capital. Last year the increase was \$112,238,512. The current filing will increase rates to residential customers by \$.58 per month. This will increase the current residential customer charge from \$15.93 to \$16.51 per month. The increase is currently scheduled to go into effect on May 27. Under the GRIP statute cities may not challenge the Company’s request. The only action Texas City may take is to suspend the effective date of the rate increase by 45 days. The attached resolution in effect requests the delay.

WHEREAS, it is incumbent upon the City, as a regulatory authority, to examine the GRIP Rate Increases to determine its compliance with the Texas Utilities Code.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF TEXAS CITY, TEXAS:
