A RESOLUTION CANVASSING THE ELECTION RETURNS FOR THE CITY OF TEXAS CITY'S GENERAL ELECTION HELD ON TUESDAY, NOVEMBER 3, 2020; AND PROVIDING THAT THIS RESOLUTION SHALL BECOME EFFECTIVE FROM AND AFTER ITS PASSAGE AND ADOPTION.
