Introduction

The Bullet-Resistant Shield Grant Program equips law enforcement officers at risk of shootings with bullet-resistant shields.

Certifications

In addition to the requirements found in existing statute, regulation, and the funding announcement, this program requires applicant organizations to certify compliance with the following:

- Solo Officer Deployment
- Officer Team Deployment
- Follow-On Responders (Rescue Task Force)

ALERRT Training

All officers provided with a grant funded ballistic shield must have either attended 16 hours of ALERRT (Advanced Law Enforcement Rapid Response Training) within the last 24 months or commit to attend within the next 24 months. NIJ Ballistic Shield Standards

Cybersecurity Training Requirement

Project Abstract :

The funds will assist in equipping our officers with ballistic shields. By the end of 2024, all of our officers will have attended ALERRT Level 1 and will be eligible to carry these shields.

Problem Statement :

The underlying problem that the project will address is giving our officers an additional means of protection in situations that involve suspects with weapons. Currently, if an emergent situation occurred at one of our schools, officers would have to make entry with limited protection from various weapons.

Supporting Data :

The majority of officers only have body armor vests which will not protect against certain firearms, like rifle rounds or armor piercing rifles. Though our officers are trained to enter a location and eliminate the threat, these shields will give our officers a higher survival rate if the threats open fires on officers.

Project Approach & Activities:

This project will allot our department the funds necessary to purchase ballistic shields to help protect our officers during critical incidents involving weapons that can pierce their body armor vests.

Capacity & Capabilities:

Our organization is composed of nearly 100 sworn officers and approximately 65 frontline patrolmen. The majority of our officers have attended some sort of active shooter training and others have attended the ALERRT training. In 2023, we sent six officers to ALERRT Level 1 train the trainer. We are currently running ALERRT Level 1 courses to get all of our officers through the state mandated course as well as several officers in our region. ALERRT training is now a priority for all of our officers. These shields will allow our officers to eliminate a threat more safely than without.

Performance Management :

The applicant organization will measure success for this project by maintaining safety of our officers. The goal of this project is to purchase ballistic shields and make sure each officer ends his daily tour of duty without injury.

Target Group :

These ballistic shields will assist our agency, each individual officer who is able to carry one of these shields

and possibly even the public if an victim needs to be shielded while trying to get out of an area safely.

Evidence-Based Practices:

In 2018, our officers were some of the first responding officers on scene of the Santa Fe High School shooting. Several of our officers entered the building first to eliminate the threat. Fortunately, the threat cooperated and was taken into custody. If/when something like this happens again, we might not be so fortunate. With the use of ballistic shields, our officers have a higher rate of survival.
