

RESOLUTION NO. 2024-141

A RESOLUTION CASTING THE CITY OF TEXAS CITY'S 221 VOTES TO NOMINATE ROBIN COLLINS, MATT DOYLE, AND DONALD GARTMAN AS CANDIDATES TO SERVE ON THE BOARD OF DIRECTORS OF THE GALVESTON CENTRAL APPRAISAL DISTRICT; AND PROVIDING THAT THIS RESOLUTION SHALL BECOME EFFECTIVE FROM AND AFTER ITS PASSAGE AND ADOPTION.

WHEREAS, this is election year for the Board of Directors of the Galveston Central Appraisal District; and

WHEREAS, the Board of Directors consists of five (5) member who serve two (2) year terms; and

WHEREAS, the City of Texas City is a voting unit entitled to vote for up to five (5) candidates from a ballot submitted by the Galveston Central Appraisal District, if so desired; and,

WHEREAS, the City Commission of the City of Texas City, Texas, nominates Robin Collins, Matt Doyle, and Donald Gartman as the candidates for the Board of Directors of the Galveston Central Appraisal District; and

WHEREAS, the Board of Directors of the Galveston Central Appraisal District is requesting that the City Commission of the City of Texas City, Texas, cast its votes for the nominated candidates by written Resolution to the Chief Appraiser before December 15, 2024.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF TEXAS CITY, TEXAS:

SECTION 1: The City Commission of the City of Texas City, Texas, is hereby casting its 221 votes to nominate Robin Collins, Matt Doyle, and Donald Gartman, the elected candidates to serve on the Board of Directors for the Galveston Central Appraisal District as attached by the Ballot labeled as "**Exhibit A**" and made a part hereto and hereof.

SECTION 2: That the number of votes cast for the candidate(s), as exhibited in the attached ballot, be submitted by the City of Texas City to the Galveston Central Appraisal District.

SECTION 3: That the City Commission of the City of Texas City, Texas, hereby directs the City Secretary to submit a certified and true copy of this Resolution to the Chief Appraiser of the Galveston Central Appraisal District before December 15, 2024.

SECTION 4: That this Resolution shall be in full force and effect from and after its passage and adoption.
