

**RESOLUTION NO. 2025-141**

**A RESOLUTION CASTING THE CITY OF TEXAS CITY'S 217 VOTES TO NOMINATE MATTHEW DOYLE AS A CANDIDATE TO SERVE ON THE BOARD OF DIRECTORS OF THE GALVESTON CENTRAL APPRAISAL DISTRICT; AND PROVIDING THAT THIS RESOLUTION SHALL BECOME EFFECTIVE FROM AND AFTER ITS PASSAGE AND ADOPTION.**

**WHEREAS**, this is a selection year for the Board of Directors of the Galveston Central Appraisal District; and,

**WHEREAS**, the Board of Directors consists of nine (9) total members, including five (5) appointed members who serve (2) year staggered terms, beginning January 1, 2026, through December 31, 2027; in addition, there are three (3) elected members, and the Tax-Assessor Collector, who serves as a voting ex officio member; and,

**WHEREAS**, the City of Texas City is a voting unit entitled to vote for up to two (2) candidates from a ballot submitted by the Galveston Central Appraisal District, if so desired; and,

**WHEREAS**, the City Commission of the City of Texas City, Texas, nominates Matthew Doyle as the candidate for the Board of Directors of the Galveston Central Appraisal District; and,

**WHEREAS**, the Board of Directors of the Galveston Central Appraisal District is requesting that the City Commission of the City of Texas City, Texas, cast its votes for the nominated candidate by written Resolution to the Chief Appraiser before December 14, 2025.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF TEXAS CITY, TEXAS:**

**SECTION 1:** That the City Commission of the City of Texas City, Texas, is hereby casting its 217 votes for Matt Doyle, the elected candidate, to serve on the Board of Directors for the Galveston Central Appraisal District for the term January 1, 2026, through December 31, 2027.

**SECTION 2:** That the number of votes cast for the candidate(s), as exhibited in the attached ballot, be submitted by the City of Texas City to the Galveston Central Appraisal District.

**SECTION 3:** That the City Commission of the City of Texas City, Texas, hereby directs the City Secretary to submit a certified and true copy of this Resolution to the Chief Appraiser of the Galveston Central Appraisal District before December 14, 2025.

**SECTION 4:** That this Resolution shall be in full force and effect from and after its passage and adoption.
