

## **RESOLUTION 15-**

### **A RESOLUTION AMENDING THE BOUNDARIES OF STREET MAINTENANCE DISTRICTS WITHIN THE CITY OF BILLINGS.**

WHEREAS, under Title 7, Chapter 12 of the Montana Code Annotated, the City of Billings is authorized to create Street Maintenance Districts for the maintenance of all or part of the public right of way in such districts; and

WHEREAS, under Title 7, Chapter 12 of the Montana Code Annotated, the City of Billings is authorized to alter said Street Maintenance Districts in any succeeding calendar year after the Street Maintenance Districts have been defined ; and

WHEREAS, it is in the best interest of the City that the City be divided into two (2) Street Maintenance Districts as allowed under MCA 7-12-4401,

### **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BILLINGS, MONTANA:**

1. That basic level of street maintenance service is defined as:
  - a. Graveling, oiling, chip sealing, seal coating, overlaying, general cleaning, leaf and debris removal, the operation, maintenance, and repair of traffic signal systems, the repair of traffic signs, the placement and maintenance of pavement markings, curb and gutter repair, sidewalk repair, and general street repair
  - b. Sweeping of arterial streets typically no more than five times per year, collector streets no more than three times per year, and local streets no more than twice per year. Entry points to the City may be swept more frequently.
  - c. Snow plowing on collector and arterial streets.
  - d. Snow removal on arterial streets as determined by Public Works Director or designee.
  - e. Any street maintenance, including but not limited to, storms and other events creating a need for heightened street maintenance services as determined by the City Administrator or designee.
2. That Street Maintenance Number One (1) District is hereby defined as shown on the map attached hereto and by this reference made a part hereof. Number One (1) District shall be the portions of the downtown area shown on the map attached to the resolution on file with the City Clerk for street maintenance in excess of the basic level of street maintenance service as defined above.
3. That Street Maintenance Number Two (2) District is hereby amended pursuant to MCA 7-12-4403 to include within its boundaries all lots and parcels of land located within the boundaries of the corporate limits of the City of Billings including lots and parcels annexed into the City on or after the date of this resolution. Number Two (2) District includes all maintenance as defined above as basic level of street maintenance.

4. That this resolution supersedes all previous resolutions creating and amending street maintenance districts.
5. That this Resolution shall be effective July 1, 2015.
