
Said easement and right-of-way contains 600 square feet more or less.

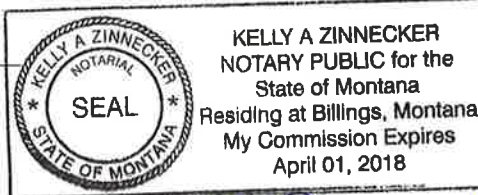

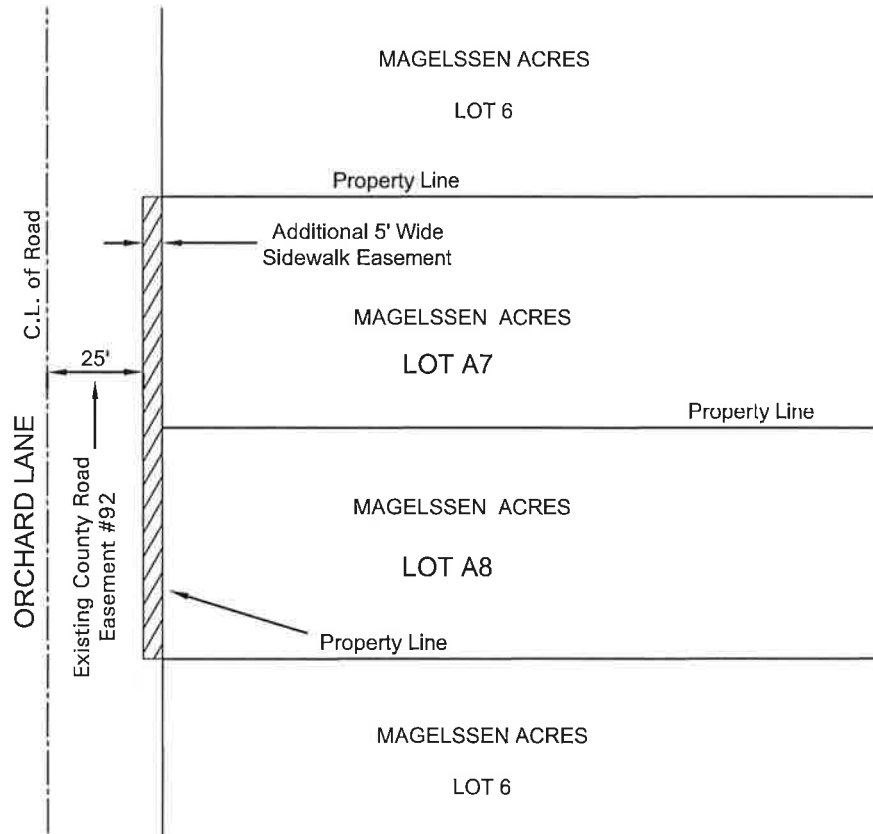

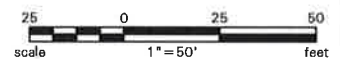
