

## **RESOLUTION NO. 18 -**

A RESOLUTION OF THE CITY OF BILLINGS TO CONSIDER ANNEXING TERRITORY UNDER TITLE 7, CHAPTER 2, PART 43 OF THE MONTANA CODE ANNOTATED, AND FIXING A DATE FOR A PUBLIC HEARING ON THE QUESTION OF ANNEXATION

WHEREAS, the City Council of the City of Billings has determined that it is in the best interest of the City of Billings to annex the territory hereinafter described; and

WHEREAS, the City Council intends to consider annexing said territory pursuant to Title 7, Chapter 2, Part 43 of the Montana Code Annotated; and

WHEREAS, the boundaries of the territory that the City Council intends to consider annexing is particularly described as follows:

Tracts of land situated in the NE1/4, the SE1/4, and the SW 1/4 of Section 34, T.1N., R.26E., P.M.M., Yellowstone County, Montana, more particularly described as:

Tracts of land being known as Coulson Park and being divided into two portions by Interstate 90, creating a north and a south portion:

The North portion being wholly surrounded on the East by the Yellowstone River, on the South by Interstate 90, on the west by Certificate of Survey No. 684, Recorded March 8, 1955, under Document Number 539388, of record and on file in the office the Yellowstone County, Clerk and Recorder's, and on the North by Montana Rail Link Rail Road Right-Of-Way.

The South portion being wholly surrounded on the East by the Yellowstone River, on the South by the South line of Section 34, T.1N., R.26E., P.P.M., on the west by Interstate 90, on the North by Tract 2, Certificate of Survey 1037, Recorded December 23, 1966,

under Document Number 790614, of record and on file in the office the Yellowstone County, Clerk and Recorder's and Interstate 90.

Containing 13.52 gross acres more or less.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BILLINGS, MONTANA, AS FOLLOWS:

1. The Billings City Council intends to consider annexation of the above-described property.
2. Notice of the City Council's intent to annex said territory shall be published as provided in M.C.A, Title 7, Chapter 2, Part 4313, with notice that for a period of 20 days after first publication of the notice, the Billings City Clerk will receive written comments approving or disapproving of the proposed extension of the boundaries of the City of Billings.
3. The City Clerk shall forward all written communication received by the Clerk to the City Council for consideration.
4. A public hearing for the question of annexation of said territory shall be held on June 25, 2018.
5. PROCEDURE. All procedures as required under M.C.A., Title 7, Chapter 2, Part 43, have been duly and properly followed and taken.
