

Contract for Professional Engineering Services
City of Billings W.O. 19-11
WRF Nutrient Recovery and Biosolids Facilities Plan

In consideration of the mutual promises herein, City of Billings and HDR Engineering, Inc. agree as follows. This Contract consists of:

- Part I, consisting of 15 Sections of Special Provisions;
- Part II, consisting of 11 Sections of General Provisions;
- Appendix A consisting of 6 pages (Basic Services of Engineer);
- Appendix B consisting of 2 pages (Methods and Times of Payment);
- Appendix C consisting of 1 pages (Additional Services of Engineer);
- Appendix D consisting of 1 pages (Schedule of Professional Fees);
- Appendix E consisting of 1 pages (Project Schedule);
- Appendix F consisting of 21 pages (Certificate(s) of Insurance); and

PART I
SPECIAL PROVISIONS

Section 1. Definitions.

In this Contract:

- A. "Administrator" means the City Engineer of the Engineering Division of the Public Works Department or his designee.
- B. "Billings" means the City of Billings.
- C. "Contractor" means HDR Engineering, Inc.

Section 2. Scope of Services.

- A. The Contractor shall perform professional services in accordance with Appendix A, which is attached hereto and incorporated in this Section by reference.
- B. Billings shall pay the Contractor in accordance with Section 4.
- C. Billings shall not allow any claim for services other than those described in this Section. However, the Contractor may provide, at its own expense, any other services that are consistent with this Contract.

Section 3. Time for Performance.

- A. This Contract becomes effective when signed on behalf of Billings.
- B. The Contractor shall commence performance of the Work described in Section 2 on receipt of written Notice to Proceed and complete that performance in accordance with the schedule set forth in Appendix E.
- C. This Contract shall terminate at midnight on December 31, 2019.

Section 4. Compensation; Method of Payment.

- A. Subject to the Contractor's satisfactory performance, Billings shall pay the Contractor no more than One Hundred Ninety Five Thousand Dollars and NO/100 (\$195,000.00) in accordance with this Section and Appendix B.
- B. Each month, or at the conclusion of each phase of the Work for which payment is due, as negotiated on a per-task basis, the Contractor shall present a bill to the Administrator describing the Work for which it seeks payment and documenting expenses and fees to the satisfaction of the Administrator. If any payment is withheld because the Contractor's performance is unsatisfactory, the Administrator must, within ten (10) days of the payment denial, notify the Contractor of the payment denial and set forth, with reasonable specificity, what was unsatisfactory and why. Billings will pay Contractor within 30 days of receiving an acceptable invoice.
- C. The Contractor is not entitled to any compensation under this Contract, other than is expressly provided for in this Section.
- D. As a condition of payment, the Contractor shall have paid all City taxes currently due and owing by the Contractor.

Section 5. Termination of the Contractor's Services.

The Contractor's services under Section 2 of this Part may be terminated:

- A. By mutual consent of the parties.
- B. For the convenience of Billings, provided that Billings notifies the Contractor in writing of its intent to terminate under this paragraph at least 10 days prior to the effective date of the termination.
- C. For cause, by either party where the other party fails in any material way to perform its obligations under this Contract. Termination under this Subsection is subject to the condition that the terminating party notifies the other party of its intent to terminate, stating with reasonable specificity the grounds therefor, and the other party fails to cure the default within 30 days after receiving the notice.

Section 6. Duties Upon Termination

- A. If Billings terminates the Contractor's services for convenience, Billings shall pay the Contractor for its actual costs reasonably incurred in performing before termination and Billings shall pay for services rendered prior to termination. Payment under this Subsection shall never exceed the total compensation allowable under Section 4 of this Part. All finished and unfinished documents and materials prepared by the Contractor shall become the property of Billings.

- B. If the Contractor's services are terminated for cause, Billings shall pay the Contractor the reasonable value of the services satisfactorily rendered prior to termination, less any damages suffered by Billings because of the Contractor's failure to perform satisfactorily. The reasonable value of the services rendered shall never exceed ninety percent (90%) of the total compensation allowable under Section 4 of this Part. Any finished or unfinished documents or materials prepared by the Contractor under this Contract shall become the property of Billings at its option.
- C. If the Contractor receives payments exceeding the amount to which it is entitled under Subsections A or B of this Section, he shall remit the excess to the Administrator within 30 days of receiving notice to do so.
- D. The Contractor shall not be entitled to any compensation under this Section until the Contractor has delivered to the Administrator all documents, records, Work product, materials and equipment owned by Billings and requested by the Administrator.
- E. If the Contractor's services are terminated for whatever reason the Contractor shall not claim any compensation under this Contract, other than that allowed under this Section.
- F. If a final audit has not been performed before the Contractor's services are terminated, Billings may recover any payments for costs disallowed as a result of the final audit.
- G. Except as provided in this Section, termination of the Contractor's services under Section 5 of this Part does not affect any other right or obligation of a party under this Contract.

Section 7. Insurance.

- A. The Contractor shall maintain in good standing the insurance described in Subsection B of this Section. Before rendering any services under this Contract, the Contractor shall furnish the Administrator with proof of insurance in accordance with Subsection B of this Section.
- B. The Contractor shall provide the following insurance:
 - 1. Workers' compensation and employer's liability coverage as required by Montana law.
 - 2. Commercial general liability, including contractual and personal injury coverage's -- \$1,500,000 per occurrence.
 - 3. Commercial automobile liability -- \$1,500,000 per accident.
 - 4. Professional liability in the amount of \$1,500,000 per claim.
- C. Each policy of insurance required by this Section shall provide for no less than 30 days' advance notice to Billings prior to cancellation.
- D. Billings SHALL be listed as an additional insured on all policies except Professional Liability and Worker's Compensation Policies. In addition, all policies except Professional Liability and Worker's Compensation shall contain a waiver of subrogation against Billings.

Section 8. Assignments.

Unless otherwise allowed by this Contract or in writing by the Administrator, any assignment by the Contractor of its interest in any part of this Contract or any delegation of duties under this Contract shall be void, and an attempt by the Contractor to assign any part of its interest or delegate duties under this Contract shall give Billings the right immediately to terminate this Contract without any liability for Work performed.

Section 9. Ownership; Publication, Reproduction and Use of Material.

- A. Except as otherwise provided herein, all data, documents and materials produced by the Contractor under this Contract shall be the property of Billings, which shall retain the exclusive right to publish, disclose, distribute and otherwise use, in whole or in part, any such data, documents, or other materials. Exclusive rights shall not be attributed to portions of such materials presently in the public domain or which are not subject to copyright. Contractor shall retain rights to pre-existing proprietary property including but not limited to interactive models. The Contractor shall have the right to include photographic or artistic representations of the design and construction of the Project among the Contractor's promotional and professional materials. The Contractor's materials shall not include Billings' confidential or proprietary information regardless of whether Billings has previously advised the Contractor in writing of the specific information considered by Billings to be confidential and proprietary.
- B. Equipment purchased by the Contractor with Contract funds: See Appendix A, Section 3. Scope of Work.
- C. Should Billings elect to reuse Work products provided under this Contract for other than the original project and/or purpose, Billings will indemnify and hold harmless the Contractor from any and all claims, demands and causes of action of any kind or character arising as a result of reusing the documents developed under this contract. Additionally, any reuse of design drawings or specifications provided under this Contract must be limited to conceptual or preliminary use for adaptation, and the original Contractor's or subcontractor's signature, professional seals and dates removed. Such reuse of drawings and specifications, which require professional seals and dates removed, will be signed, sealed, and dated by the professional who is in direct supervisory control and responsible for adaptation.

Section 10. Notices.

Any notice required pertaining to the subject matter of this Contract shall be either sent via facsimile (FAX) or mailed by prepaid first class registered or certified mail, return receipt requested to the following addresses:

Notices are effective upon the earlier of receipt, proof of good transmission (facsimiles only), or 5 days after proof of proper posting.

Section 11. Contract Budget.

In connection with its performance under this Contract, the Contractor shall not make expenditures other than as provided in line items in the Contract budget.

Section 12. Force Majeure.

- A. Any failure to perform by either party due to force majeure shall not be deemed a violation or breach hereof.
- B. As used in this Contract, force majeure is an act or event of substantial magnitude, beyond the control of the delayed party, which delays the completion of this Contract, including without limitation:
 - 1. Any interruption, suspension or interference resulting solely from the act of Billings or neglect of Billings not otherwise governed by the terms of this Contract.
 - 2. Strikes or Work stoppages.
 - 3. Any interruption, suspension or interference with the project caused by acts of God, or acts of a public enemy, wars, blockades, insurrections, riots, arrests or restraints of governments and people, civil disturbances or similar occurrences.
 - 4. Order of court, administrative agencies or governmental officers other than Billings.

Section 13. Financial Management System.

The Contractor shall establish and maintain a financial management system that:

- A. Provides accurate, current, and complete disclosure of all financial transactions relating to the Contract;
- B. Maintains separate accounts by source of funds for all revenues and expenditures and identifies the source and application of funds for the Contractor's performance under this Contract, including information pertaining to subcontracts, obligations, unobligated balances, assets, liabilities, outlays and income;
- C. Effectively controls and accounts for all municipal funds and Contract property;
- D. Compares actual expenditures with budgeted amounts and relates financial information to performance or productivity data including unit cost information where applicable;
- E. Allocates administrative costs to direct service delivery units;
- F. Minimizes the time between receipt of funds from Billings and their disbursement by the Contractor;
- G. Provides accounting records supported by source documentation; and

- H. Provides a systematic method assuring the timely and appropriate resolution of audit findings and recommendations.

Section 14. Funding Requirements.

In the event that any funding source for this Contract should impose additional requirements upon Billings for the use of those funds, the Contractor agrees to abide by those additional requirements immediately upon receipt of written notice thereof from Billings.

Section 15. Subcontracts.

The Contractor may enter into subcontracts for the purchase of goods and services necessary for the performance of this Contract, provided:

- A. Every subcontract shall be reduced to writing and contain a precise description of the services or goods to be provided and the nature of the consideration paid therefor.
- B. Every subcontract under which the Contractor delegates the provision of services shall be subject to review and approval by the Administrator before it is executed by the Contractor.
- C. Every subcontract in an amount exceeding \$1,000 shall require reasonable access to business records of the subcontractor relating to the purchase of goods or services pursuant to the subcontract.

PART II GENERAL CONTRACT PROVISIONS

Section 1. Relationship of Parties.

The Contractor shall perform its obligations hereunder as an independent Contractor of Billings. Billings may administer the Contract and monitor the Contractor's compliance with its obligations hereunder. Billings shall not supervise or direct the Contractor other than as provided in this Section.

Section 2. Nondiscrimination.

- A. The Contractor will not discriminate against any employee or applicant for employment because of race, color, religion, national origin, ancestry, age, sex, or marital status or who is a "qualified individual with a disability" (as that phrase is defined in the Americans With Disabilities Act of 1990). The Contractor will take affirmative action to ensure that applicants are employed and that employees are treated during employment without regard to their race, color, religion, or mental or physical impairment/disability. Such action shall include, without limitation, employment, upgrading, demotion or transfer, recruitment or recruiting advertising, layoff or termination, rates of pay or other forms of compensation, and selection for training including apprenticeship. The Contractor agrees to post, in conspicuous places available to employees and applicants for employment, notices setting forth the provisions of this non-discrimination clause.
- B. The Contractor shall state, in all solicitations or advertisements for employees to Work on Contract jobs, that all qualified applicants will receive equal consideration for employment without regard to race, color, religion, national origin, ancestry, age, sex or marital status, or mental or physical impairment/disability.
- C. The Contractor shall comply with any and all reporting requirements that may apply to it which the City of Billings may establish by regulation.
- D. The Contractor shall include the provisions of Subsections A through C of this Section in every subcontract or purchase order under this Contract, so as to be binding upon every such subcontractor or vendor of the Contractor under this Contract.
- E. The Contractor shall comply with all applicable federal, state, and city laws concerning the prohibition of discrimination.
- F. The Contractor and subcontractor shall abide by the requirements of 41 CFR 60-300.5(a) and 41 CFR 60-741.5(a), which prohibit discrimination against qualified protected veterans and/or qualified individuals on the basis of disability, and requires affirmative action by covered prime contractors and subcontractors to employ and advance in employment qualified protected veterans and individuals with disabilities.

Section 3. Permits, Laws, and Taxes.

The Contractor shall acquire and maintain in good standing all permits, licenses and other entitlements necessary to its performance under this Contract. All actions taken by the

Contractor under this Contract shall comply with all applicable statutes, ordinances, rules and regulations. The Contractor shall pay all taxes pertaining to its performance under this Contract.

Section 4. Nonwaiver.

The failure of either party at any time to enforce a provision of this Contract shall in no way constitute a waiver of the provision, nor in any way affect the validity of this Contract or any part hereof, or the right of such party thereafter to enforce each and every provision hereof.

Section 5. Amendment.

- A. This Contract shall only be amended, modified or changed by a writing, executed by authorized representatives of the parties, with the same formality as this Contract was executed.
- B. For the purposes of any amendment modification or change to the terms and conditions of this Contract, the only authorized representatives of the parties are:

Contractor: Jared Harris, Amanda McInnis, or Authorized Signatory

Billings: City Council or Authorized Designee

- C. Any attempt to amend, modify, or change this Contract by either an unauthorized representative or unauthorized means shall be void.

Section 6. Jurisdiction; Choice of Law.

Any civil action rising from this Contract shall be brought in the District Court for the Thirteenth Judicial District of the State of Montana, Billings. The law of the State of Montana shall govern the rights and obligations of the parties under this Contract.

Section 7. Severability.

Any provision of this Contract decreed invalid by a court of competent jurisdiction shall not invalidate the remaining provisions of the Contract.

Section 8. Integration.

This instrument and all appendices and amendments hereto embody the entire agreement of the parties. There are no promises, terms, conditions or obligations other than those contained herein; and this Contract shall supersede all previous communications, representations or agreements, either oral or written, between the parties hereto.

Section 9. Liability.

The Contractor shall indemnify, defend, save, and hold Billings harmless from any and all claims, causes of action, lawsuits, damages, judgments, liabilities, and litigation costs and

expenses including reasonable attorneys' fees and costs, arising from any wrongful or negligent act, error or omission of the Contractor or any agent, employee or subcontractor as a result of the Contractor's or any subcontractor's performance pursuant to this Contract.

- A. The Contractor shall not indemnify, defend, save and hold Billings harmless from claims, causes of action, lawsuits, damages, judgments, liabilities, and litigation costs and expenses or attorneys' fees and costs arising from wrongful or negligent acts, error or omission solely of Billings occurring during the course of or as a result of the performance of the Contract.
- B. Where claims, lawsuits or liability, including attorneys' fees and costs arise from wrongful or negligent act of both Billings and the Contractor, the Contractor shall indemnify, defend, save, and hold Billings harmless from only that portion of claims, causes of action, lawsuits, damages, judgments, liabilities, and litigation costs and expenses including attorneys' fees and costs, which result from the Contractor's or any subcontractor's wrongful or negligent acts occurring as a result from the Contractor's performance pursuant to this Contract.

Section 10. Inspection and Retention of Records.

The Contractor shall, at any time during normal business hours and as often as Billings may deem necessary, make available to Billings, for examination, all of its records with respect to all matters covered by this Contract for a period ending three years after the date the Contractor is to complete performance in accordance with Section 2 of the Special Provisions. Upon request, and within a reasonable time, the Contractor shall submit such other information and reports relating to its activities under this Contract, to Billings, in such form and at such times as Billings may reasonably require. The Contractor shall permit Billings to audit, examine and make copies of such records, and to make audits of all invoices, materials, payrolls, records of personnel, and other data relating to all matters covered by this Contract. Billings may, at its option, permit the Contractor to submit its records to Billings in lieu of the retention requirements of this Section.

Section 11. Availability of Funds.

Payments under this Contract may require funds from future appropriations. If sufficient funds are not appropriated for payments required under this Contract, this Contract shall terminate without penalty to Billings; and Billings shall not be obligated to make payments under this Contract beyond those which have previously been appropriated.

Appendix A

Basic Services of Engineer City of Billings W.O. 19-11 WRF Nutrient Recovery and Biosolids Facilities Plan

Section 1. Engineer's Rights and Duties.

- A. To furnish all labor, materials, equipment, supplies, and incidentals necessary to conduct and complete the Engineer's portion of the project as defined in the scope of work and to prepare and deliver to Billings all plans, specifications, bid documents, and other material as designated herein.
- B. Ascertain such information as may have a bearing on the work from local units of government, utility companies, and private organizations and shall be authorized to procure information from other authorities besides Billings, but shall keep Billings advised as to the extent of these contacts and the results thereof.
- C. Prepare and present such information as may be pertinent and necessary in order for Billings to pass critical judgment on the features of the work. The Engineer shall make changes, amendments or revisions in the detail of the work as may be required by Billings. When alternates are being considered, Billings shall have the right of selection.
- D. Engineer's work shall be in accordance with the standards of sound engineering and present City, State, and National standards and policies currently in use.
- E. Conform to the requirements of the Montana Code Annotated Title 18 "Public Contracts" and more particularly Sections 18-2-121 and 18-2-122, and all other codes of the State of Montana applicable to providing professional services including codes and standards nationally recognized.
- F. The Engineer shall certify with the submission of final plans that the plans are in conformance with applicable sections of Title 69, Chapter 4, Part 5, of the Montana Code Annotated as pertaining to existing utilities.
- G. To perform professional services in connection with the project and will serve as Billings' representative in those phases of the project to which this agreement applies.
- H. Where Federal funds are involved, the necessary provisions to meet all requirements will be complied with and documents secured and placed in the bidding documents.
- I. Submit an estimated progress schedule as to time and costs at the beginning of the work, and monthly progress reports thereafter until complete. The reports will include any problems, potential problems, and delays as foreseen by the Engineer. Reports will be submitted in a timely manner to permit prompt resolution of problems.

- J. Contract administration duties will include review of contractor certified payrolls for wage rate compliance. Discrepancies in certified payrolls will be resolved with the Contractor. A signed Engineer's Payroll Check Sheet (included in the Standard Modifications to MPWSS) will be submitted as proof of this review with one copy of each payroll.
- K. Name a Task Director who shall be the liaison between Billings and the Engineer. For this project the Task Director designated for the Engineer is Amanda McInnis working under the Principal-in-Charge, Jared Harris.

Section 2. Billings Rights and Duties.

- A. To furnish all labor, materials, equipment, supplies, and incidentals necessary to conduct and complete Billings' portion of the project as designated in the scope of work.
- B. Name a Task Director who shall be the liaison between the Engineer and Billings. For this project, the Task Director designated is Randy Straus, working under the City Engineer, Debi Meling.

Section 3. Scope of Work.

The City of Billings would like to update the review of the solids handling practices, nutrient recovery, and biogas recovery analysis from the Facility Plan and the Nutrient Design, looking specifically at primary clarifier requirements, primary sludge thickening, Calprex/other recent nutrient recovery developments, and potential associated benefits to the biogas composition. The City's goals are to:

- Recover phosphorous
- Reduce hydrogen sulfide in the biogas
- Increase dewaterability of the biosolids
- Reduce polymer usage for dewatering
- Provide volatile fatty acids for the biological nutrient removal (BNR) process
- Increase biogas production
- Reuse existing infrastructure to the extent possible
- Meet goals in the most cost effective manner

The plan includes the following components:

1. Summarize and update projected residuals in the process.
2. Evaluate best use and operation of primary clarifiers.
3. Update phosphorous recovery evaluation with a focus on Calprex.
4. Analyze other side stream treatment options for nitrogen and/or ammonia removal.
5. Determine need for third gravity thickener.
6. Update recommendations for primary clarifiers, residuals, side stream treatment and nutrient recovery and provide recommendation for hydrogen sulfide (H₂S) reduction in the wastewater system.
7. Summarize in a Report.

DETAIL SCOPE OF SERVICES

This scope of services is for HDR to assist the City through various technical assistance activities related to the Water Reclamation Facility (WRF) Nutrient Recovery and Biosolids Facility Plan project. The proposed scope of Consultant services are identified in the following tasks.

TASK SERIES 100 – PROJECT MANAGEMENT AND ADMINISTRATION

101 – Project Management

Project manager and project accountant will initiate project internally, monitor the project schedule/budget, prepare monthly invoices and close out the project.

- Deliverable: Monthly invoices

102 – Project Coordination Meetings

HDR will conduct meetings with City staff as necessary to review project progress. Four project meetings are anticipated.

- Deliverable: Agenda and meeting minutes for each meeting

TASK SERIES 200 – INNOVATION WORKSHOP

Objective

HDR expertise and the City of Billings staff shall join together for a one-day workshop on innovative ideas for the integration of the nutrient recovery, side stream treatment and biosolids management including their potential impacts on the rest of the facility.

201 – Innovation Workshop

The Innovation Workshop will be held in Billings for local staff and via video conference for out-of-state support. The meeting will include JB Neethling and Mario Benisch and focus on developing alternatives for solids impacts and nutrient recovery. A focus will include reuse of existing infrastructure. A 4-hour video conference is planned, with an HDR internal prep meeting beforehand.

- Deliverables: Workshop meeting agenda and notes

TASK SERIES 300 – EVALUATE CURRENT PRIMARY CLARIFICATION AND POTENTIAL THIRD GRAVITY THICKENER

Objective

A summary of current and projected residuals quantities will be summarized from the Nutrient Design and Facility Plan.

301 – Evaluation Primary Clarification and Potential Third Gravity Thickener

HDR will review primary clarifier requirements as well as potential modes of operation. Settling sludge in the primary clarifiers or using one of the clarifiers as a gravity thickener would free up the gravity thickeners for other uses, such as side stream treatment. Similarly, the potential for a third gravity thickener will be evaluated, as well as how a third gravity thickener could affect plant processes. Montana Department of Environmental Quality (MDEQ) design criteria for primary clarifiers will be reviewed to project capacity of existing clarifiers. HDR will coordinate with MDEQ on weir loading rate criteria and limitations on continuing to get a variance for this criteria. Evaluation will also look at partial/full/seasonal bypassing of primary clarification and the effects on the plant process.

- Deliverable: A summary of current and future residual quantities and primary clarifier and gravity thickener options.

TASK SERIES 400 – EVALUATE RESOURCE RECOVERY ALTERNATIVES

Objective

One of the fundamental keys to the goals of the WRF has always been the recovery of phosphorus from the treatment process. There are a variety of phosphorus recovery technologies that can be employed to recover phosphorus during the treatment process, with the CalPrex process being especially applicable to the goals of the City. The Calprex process is a phosphorus recovery process that creates a fertilizer called Brushite. It uses acid phase digestion to solubilize phosphorus, which then reacts with calcium addition to crystallize the phosphorus upstream of anaerobic digestion. The Calprex process can be a good fit with (BNR) facilities because it captures the phosphorus upstream of the digesters (before it can form struvite in the digester) and creates a carbon-rich recycle stream that can improve nitrogen removal in the BNR process. Sampling work suggests that phosphorus is the limiting nutrient in the Yellowstone River, and consequently it makes sense from a water quality perspective to focus on reducing phosphorus loading. Additionally, dewaterability would likely improve and polymer demand would decrease. Other possible processes for phosphorous removal include Airpex, MultiForm Harvest and Ostara.

401- Calprex Evaluation

The objective of this task is to review Calprex in the context of existing and possible future tankage at the WRF site, and compare it at a screening level with other alternatives.

402 – Additional Alternative Technologies

The objective of this task is to review up to three other technologies in the context of existing and possible future tankage at the WRF site, and compare each alternative at a screening level with each other and Calprex. Possibilities will be included in the

discussion of the Innovation Workshop and may include Annamox, or alternative phosphorus recovery and ammonia/nitrogen reduction technologies.

403- Preliminary Biowin Modeling

This task will include Biowin modeling of each alternative to determine the localized impacts on the plant.

404 – Preliminary Cost Estimates

The purpose of this task is evaluate the costs of the alternatives developed. Preliminary capital and O&M costs will be calculated and presented as alternatives to the current CIP.

405 – Alternatives Analysis

The evaluations for alternatives and the cost estimates will be used in this task to perform an alternatives analysis. Evaluation criteria will be weighted with the costs for the full evaluation.

406 - Bench Scale Testing

This task also includes assistance with one bench scale phosphorus release evaluation conducted at the WRF lab. Samples for TP and soluble P will be included and pH will be monitored. This test will be conducted after the plant has started up its new nutrient removal trains. The test will include one, two-day bench scale phosphorus release test.

- Deliverable: Bench Scale testing protocol.

TASK SERIES 500 – OVERALL H₂S EVALUATION OF THE WASTEWATER SYSTEM

Objective

The impacts of the elevated H₂S concentrations is being explored in the collection system under a separate project. Chemical dosing for impacts to H₂S removal in the biosolids system is also being explored by a separate project. This task will provide additional recommendations and bring together the findings of the other two projects for an overall solution.

501- H₂S Evaluation and Recommendations for the Wastewater System

This task will incorporate recommendations from the Collection System H₂S Evaluation Project, results of the Chemical Pilot Project, corrosion/odor control improvements at the WRF to provide a holistic look at the H₂S mitigation in the wastewater system and provide overall recommendations.

TASK SERIES 600 – OVERALL SOLIDS HANDLING EVALUATION, LIQUID STREAM EVALUATION AND SUMMARY REPORT

Objective

Based on the findings in Task 300, 400 and 500 an overall solids handling and liquid stream evaluation will be provided along with recommendations for current and future needs. Various solids handling options will be developed and the effects on the liquid stream will be analyzed. Options will be developed schematically and facility layouts will be developed along with major pipeline routing. The findings will be summarized in a

report along with a recommended plan. Summary of capital and O&M costs will be included for proposed improvements. In providing opinions of probable cost, HDR has no control over cost or price of labor and materials, unknown or latent conditions of existing equipment or structures that might affect operation or maintenance costs, competitive bidding procedures and market conditions, time or quality of performance by operating personnel or third parties, and other economic and operational factors that might materially affect the ultimate the project construction cost or schedule.

601- Final Biowin Modeling

This task will include Biowin modeling of the combination of recommended alternatives to summarize the projected treatment results and to determine required facility sizing.

602 – Recommendation

This task will include schematic level layouts and process flow diagrams of the recommended alternative from Task 400.

603- Biosolids Evaluation

This task will include a mass balance of the biosolids impacts of the recommendation and the impacts to the dewatering and disposal of the biosolids. Impacts to the biogas will also be evaluated.

604- Detailed Capital Cost Estimate of Recommendation

This task will include the cost estimate for implementing the recommended alternative. The schematic layout will be used to determine impacts to the site piping and integration of the alternative for an overall cost estimate.

605- Compare Recovery Recommendation to Previously Planned Facilities

This task will evaluate the recommendation in light of the expected discharge permit requirements and compare the recommendation to the facilities recommended in the Wastewater Treatment Facility Plan for comparative discharge limits

606- Final Report

This task includes the writing of the final report and documentation. A single set of review comments from the City of Billings is assumed.

- Deliverable: Three hard copies and one electronic copies of the draft and final technical memorandum.

Appendix B

Methods and Times of Payment City of Billings W.O. 19-11 WRF Nutrient Recovery and Biosolids Facilities Plan

Section 1. Payments for Basic Services.

Billings shall authorize payment to the Engineer for services performed under Appendix A of this Agreement. Partial payment shall be due the Engineer upon receipt of the Engineer's pay estimate, said estimate being proportioned to the work completed by the Engineer.

B. Final payment shall be the above stated basic fee less all previous payments.

Section 2. Payments for Extra Services when Authorized by Billings.

Requests made or conditions identified by interested groups at the agency or public meetings, which are beyond the scope and intent of this study shall be paid for based on a negotiated fee.

Section 3. Corrections.

Costs of Billings work that is required for corrections to the Engineer's work which requires redoing by Billings shall be deducted from any payments due the Engineer, if the Engineer fails to make the required corrections.

Section 4. Fee Increases

For contracts and services that are expected to require more than one (1) year to complete, the above stated basic services payments may be reviewed and adjusted annually by mutual agreement of the parties, based upon documented evidence that the Engineer's costs have increased for all comparable clients.




