

**RESOLUTION 20-**

**A RESOLUTION ADOPTING REVISED SCHEDULE OF RIGHT-OF-WAY FEES FOR THE PUBLIC WORKS DEPARTMENT**

WHEREAS, it is essential to the public health, welfare, and safety of the inhabitants of the City of Billings and its environs to provide adequate inspection and administration of operations within the City right-of-way and to provide adequate funding to meet the cost of providing said services incurred in the administration of right-of-way permits; and

WHEREAS, it has become necessary in the operation of City Engineering services to revise the right-of-way fees to levels to be consistent with the costs of administration and inspection incurred relating to the services provided.

WHEREAS, the City Council of the City of Billings did adopt Ordinance No. 12-5574 on the 25<sup>th</sup> day of June 2012, providing for the billing of solid waste collection and disposal fees on a monthly basis; and

WHEREAS, said fees are established by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BILLINGS, MONTANA:

1. That the following schedule of fees are hereby established and shall become effective July 1, 2020 and remain in effect thereafter until changed by resolution.
