1. Presentation. City of Billings BUILD Grant Kickoff: Mayor Cole kicked off the event by thanking everyone for attending! This is a time for the community to celebrate the BUILD grant. The Mayor then introduced the members of the PCC, Denis Pitman, Woody Woods, and Rod Nelson. The Mayor then gave an overview of the project and how the completion of the Skyline Trail as part of the Marathon Loop and the Inner Belt Loop is a long-time project coming to fruition.

The Mayor then thanked members of the Billings delegation and took the lead in bringing this application and project to Washington, DC. The delegation included himself; Dan Brooks, Chamber of Commerce; Steve Arveschoug, Big Sky Economic Development; Kristi Drake, Billings TrailNet; and Wyeth Friday, Director, Planning and Community Services Department.

The Mayor then asked the congressional representatives to speak. Mattie Alpert from Senator Jon Tester’s office read a statement from the Senator congratulating the community on the award. Next, Tory Kolkhorst from Senator Daines office provided a video message from the Senator congratulating the community on success. Last, Cade Overstreet from Congressman Rosendale’s office provided a

video message from the Congressman congratulating the Mayor and community of receiving BUILD grant funds.

The Mayor then asked Lucia Olivera, Division Administer from the Federal Highway Administration to give a few remarks. She is excited to bring \$11.6 million of federal funding to the Billings community, with the community's contribution, the entire project is \$18.7 million. Billings was one of many projects approved to receive BUILD funds and FHWA looks forward to working with local officials. She introduced Brian Hasselback and Alan Woodmansey from the Montana FHWA District offices and the local contacts the community will be working very closely with. There is a very rigorous process to a BUILD grant and currently the grant agreement is being developed. There are many steps to the agreement development and could take several months. Once the grant agreement is signed, this allows FHWA to reimburse the city federal funds.

The Mayor next introduced Wyeth Friday, Director of the Planning and Community Services Department. Wyeth states that this event starts a landmark event. The community commitment has been overwhelming and thanks all that have been involved.

The Mayor next introduced Kristi Drake, Executive Director, Billings TrailNet to speak. Kristi is excited about this game changer project for the community, there has been so much cooperation from everyone and specifically mentions the Billings TrailNet board who have spearheaded and approved the use of almost \$400,000 in TrailNet funding to engineer the Skyline Trail. The Mayor thanked TrailNet and also reminded that the Inner Belt Loop will also have a separated pathway.

The Mayor also gave a shout out to the Billings Chamber and Big Sky Economic Development for the valuable economic data provided in the grant and the help coordinating the Washington, DC trip.

Woody Woods comments how bike and pedestrian safety is very important to him and the Lockwood community. He's very excited to see the project completed.

Denis Pitman thanked everyone involved in receiving this grant. The Inner Belt Loop was a priority when he sat on the City Council and he is happy to see it being built.

The Mayor asked if Jennifer Owen from the Heights Task Force would like to make some comments. Jennifer states that this is such a huge project for the Heights- ever since the Father's Day tornado demonstrated the desperate need for alternate routes and connectivity in the Heights.

Rod Nelson from MDT offered congratulations and thanked the grant selection committee for reviewing all the grant application submitted, it's not an easy job!

The Mayor asked Debi Meling, Director of City Public Works to give an update on the status of the project. Debi states that this grant is challenging and they are learning as it goes. The NEPA (environmental documentation) process has started and most of the requirements before signing the grant agreement is tied to completion of tasks required by NEPA. Engineering hopes to have a preliminary report for FHWA review in July. Once NEPA documents are approved, the final engineering, right-of-way purchase and grant agreement can be completed. The Mayor asks if there are any problems with the current cost of construction materials. Debi hopes that by the time the City is ready to bid, some of that may have calmed down.

Scott Walker provided an event wrap up by thanking Jo Ann Olsen and Bill Troe from SRF Consulting for helping us develop a winning application. He also thanked all of the city staff that helped move this project forward. And finally, Katie Potts and Parker Osterloh from MDT for their support.

Mayor thanked everyone for coming including Council members Kendra Shaw and Denise Joy and the rest of the council for their support.

Rod Nelson thinks this is a great idea, a citizen advisory committee to work through this would be beneficial. Ryan Hammon, FHWA, reminded the PCC that any aesthetic inclusions would have to conform to the MUCTD guidelines set forth by FHWA. The Mayor states that we have to be mindful on what we build as we will need to work out maintenance for anything constructed. Rod Nelson will assist in setting up the citizen committee.
