

RESOLUTION NO. 25 -

A RESOLUTION OF THE CITY OF BILLINGS AMENDING RESOLUTION NO. 25-11262 ANNEXING TERRITORY UNDER TITLE 7, CHAPTER 2, PART 44 OF THE MONTANA CODE ANNOTATED.

WHEREAS, the City Council approved Resolution 25-11262 annexing the territory described below pursuant to Title 7, Chapter 2, Part 44 of the Montana Code Annotated following a public hearing on March 24, 2025, and determines it is necessary to make corrections to Resolution 25-11262; and

WHEREAS, on February 24, 2025, Council properly passed a resolution of intent to annex the property and set a public hearing on March 24, 2025; and

WHEREAS, after providing proper notice and allowing for a protest period, Council made a finding that it is in the best interest of the City of Billings to annex the territory described below; and

WHEREAS, after a public hearing on March 24, 2025, Council annexed the territory described below, subject to conditions, pursuant to Title 7, Chapter 2, Part 44 of the Montana Code Annotated; and

WHEREAS, Resolution No. 25-11262 included conditional language not necessary because the City of Billings is the recorded owner of the territory and a subdivision improvement agreement is not necessary.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BILLINGS, MONTANA:

1. TERRITORY ANNEXED. Pursuant to M.C.A., Title 7, Chapter 2, Part 44, the following territory is hereby annexed to the City of Billings:

An unplatted parcel of land situated in the northwest one-quarter (NW $\frac{1}{4}$) of the southeast one-quarter (SE $\frac{1}{4}$) of Section 10, Township 01 south, Range 26 east, P.M.M., Yellowstone County Montana, more particularly described as follows:

Beginning at the center quarter corner of said Section 10, said point being the Point of Beginning; thence S00°00'39"W a distance of 660.40 feet; thence S89°39'19"E following the northern boundary of the right-of-way for Hannon Road a distance of 988.25 feet; thence N00°07'28"E following the western boundary of Tract 1 of Certificate of Survey No. 119 Amended a distance of 661.02 feet; thence N89°41'28"W following the southern

boundary of Lot 2, Block 1 of the Western Sugar Cooperative Subdivision a distance of 988.19 feet back to the Point of Beginning. Including all adjacent rights of way of Riverside Road & Hannon Road.

Said annexation contains a net and gross area of 14.99 acres, more or less

- 3. EFFECTIVE DATE. This resolution to annex the above-described territory shall be effective March 24, 2025. This resolution shall supersede and replace Resolution No. 25-11262.
