SUBJECT: 2023 Transportation Regional Incentive Program

The Florida Department of Transportation (FDOT) District Six is pleased to announce the 2023 Transportation Regional Incentive Program (TRIP) application cycle. TRIP was created pursuant to Section 339.2819, Florida Statutes, to provide an incentive for regional planning, to leverage investments in regionally significant transportation facilities (roads and public transportation) in regional transportation areas created pursuant to Section 339.155, F.S., and link investments to growth management objectives. We invite the Southeast Florida Transportation Council (SEFTC) to apply for program funds.

Funding is subject to the availability of TRIP funds and an annual appropriation by the Legislature (spending authority). FDOT shall provide a maximum of 50% percent (%) of eligible costs for eligible projects. Regional funding partners must provide matching funds of 50% or greater. Available funding for District Six's allocation is approximately:

FY 2025	\$ 11,123,694
FY 2026	\$ 0
FY 2027	\$ 4,851,334
FY 2028	\$ 5,634,802
FY 2029	\$ 5,634,802

The application **deadline is March 1, 2023 at 5:00 pm**. The application can only be accessed and submitted through the FDOT Grants Application Process (GAP). Applicants must request user access by registering at flgap.com. For more information view [How to Submit an Application](#), and [GAP User Guide](#); hyperlinks to the aforementioned documents can be found in the attachment to this letter.


NOTE: Late submittals will not be accepted. Once the deadline passes, the system will lock out applicants from uploading applications or making changes to their applications.
