

RESOLUTION NO. 2026-R-04C

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARBLE FALLS, TEXAS, AUTHORIZING AND APPROVING AN INTERLOCAL AGREEMENT WITH BURNET COUNTY AND THE CITY OF BURNET FOR THE FORMATION OF THE "HIGHLAND LAKES SUB-REGIONAL PLANNING COMMISSION"; AND APPROVING COORDINATION WITH OTHER COUNTIES, MUNICIPALITIES, AND OTHER GOVERNMENTAL UNITS

WHEREAS, Chapter 391 of the Texas Local Government Code authorizes any combination of counties and municipalities to establish a sub-regional planning commission to address regional planning needs; and

WHEREAS, the City Council of the City of Marble Falls finds that the City and surrounding governmental entities share common planning concerns affecting transportation, infrastructure, land use, economic development, and other matters impacting the region; and

WHEREAS, cooperative planning among affected governmental entities is in the best interest of the citizens of Marble Falls and will promote orderly growth, efficient use of public funds, and protection of public health, safety, and welfare; and

WHEREAS, the City Council finds that participation in the Highland Lakes Sub-Regional Planning Commission (HLSRPC) will enhance coordination and regional collaboration consistent with Chapter 391, Texas Local Government Code including but not limited to the following:

- a) Planning for transportation systems and related infrastructure improvements;
- b) Promoting the orderly provision of streets, utilities, public facilities, health, educational, recreational, and other essential services;
- c) Supporting agriculture, business, and industry within the region;
- d) Promoting safe, healthful residential environments;
- e) Preserving historical and cultural resources;
- f) Encouraging efficient and economical use of public funds; and
- g) Cooperating with federal and state agencies on matters affecting the region.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARBLE FALLS, TEXAS, AS FOLLOWS:

Section One. Findings. The recitals set out above are hereby approved and incorporated herein for all purposes.

Section Two. Approval of Planning Commission. The City of Marble Falls hereby approves the creation Highland Lakes Sub-Regional Planning Commission, to be formed

pursuant to Chapter 391, Texas Local Government Code; and further approves the City of Marble Falls inclusions within the geographical boundaries thereof.

Section Two. Approval of the Interlocal Agreement. The instrument entitled the "*Highland Lakes Sub-Regional Planning Commission Interlocal Agreement and Articles of Formation*", attached hereto is hereby approved.

Section Three. Authorization. The Mayor is authorized and directed to execute and agreement substantially similar to the instrument referenced in Section Two herein, and to execute such ancillary instruments and take those actions that are reasonably necessary to facilitate the purpose of this Resolution.

Section Four. Open Meetings. It is hereby officially found and determined that the meeting at which this resolution was passed was open to the public and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act.

Section Five. Effective Date. That this resolution shall take effect immediately upon its passage, and approval as prescribed by law.
