The Burnet County FY2027 Proposed Budget was filed on August 14, 2026, The Budget Hearing is scheduled on Setember 8, 2026. The following items were identified by the County Judge, Elected Officials, Department Heads and the County Auditor as errors in the recording of the FY2027 Proposed Budget. Staff positions were generally corrected for actuals versus year to year carryforward.
