**ORDER FOR THE CANCELLATION OF L BAR V SUBDIVISION, A SUBDIVISION
WITHIN THE UNINCORPORATED AREA OF BURNET COUNTY AS RECORDED IN
DOCUMENT #199706702, OFFICIAL PUBLIC RECORDS OF BURNET COUNTY**

WHEREAS, Satish and Rathna Reddy, have petitioned the Burnet County Commissioner's Court for the cancellation and vacation of a subdivision known as L Bar V Subdivision and;

WHEREAS, Satish and Rathna Reddy are the fee simple owner of all lands within L Bar V Subdivision and,

WHEREAS, Cancellation of L Bar V Subdivision will not interfere with the established rights of any person owning any part of L Bar V Subdivision except for Satish and Rathna Reddy, therefore;

SO BE IT ORDERED, on this the 12th day of September, 2017 that, Pursuant to the Burnet County Subdivision Regulations, adopted January 11, 2011, Article 2, Division 1, A, and Section 232.008 of the Texas Local Government Code, the subdivision known as L Bar V Subdivision as recorded in Document #199706702, O.P.R.B.C.T. shall be cancelled and the land therein be reestablished as an acreage tract.

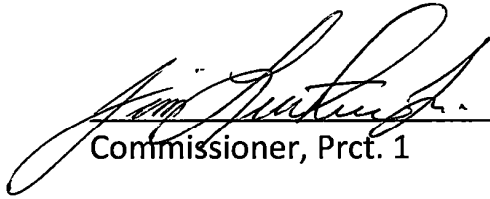

The instrument shall contain a description of the property that is currently known as L Bar V Subdivision and recorded in Document #199706702, O.P.R.B.C.T. After the instrument is filed and recorded in the Official Public Records of Burnet County, the Burnet County Chief Appraiser shall assess the property as if it had never been subdivided.

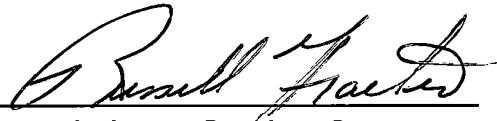


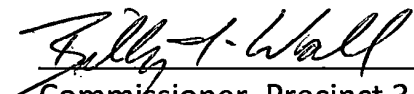
