

**CONTRACT BETWEEN BURNET COUNTY
AND
WILLIAMSON-BURNET COUNTY OPPORTUNITIES, INC.**

WHEREBY WILLIAMSON-BURNET COUNTY OPPORTUNITIES, INC. agrees to provide the Meals on Wheels Senior Nutrition Program to the County of Burnet. WILLIAMSON-BURNET COUNTY OPPORTUNITIES, INC. agrees to perform the services that are customarily performed by the WILLIAMSON-BURNET COUNTY OPPORTUNITIES, INC. and which have been provided to Burnet County in the past and paid for by Burnet County. WILLIAMSON-BURNET COUNTY OPPORTUNITIES agrees to provide these services for \$10,000.00 under this Agreement. The compensation is payable QUARTERLY IN 4 EQUAL PAYMENTS OF \$2,500.00 as determined by the Commissioners Court and provided for in the FY 2019 budget. Deducted from the gross quarterly payment will be \$422.01 for utilities for 607 N. Vanderveer Street, Burnet, Texas 78611 per MOU between Burnet County and Burnet Consolidated Independent School District. **NET QUARTERLY PAYMENT OF \$2,077.99.** Any discrepancies in payment shall be determined by the Commissioners Court Minutes and the Budget, which are on record in the County Clerk's Office in Burnet County. Any change in the Budget or monies requested will require a written revision and approval by the Commissioners Court. **This Agreement is for a period of 12 months to begin October 1, 2018 and expire September 30, 2019.** The contract will be reviewed annually, with any amendments sent to the Williamson-Burnet County Opportunities, Inc., during budget time each year. It is further provided that either party may terminate this contract at any time, with or without cause, upon not less than thirty (30) day written notice to the other party.

WILLIAMSON-BURNET COUNTY OPPORTUNITIES, INC. agrees to submit its financial statements/budget annually, during budget time. Burnet County requires this information from all entities that receive support for community services. Failure to comply with this request may result in loss of support during the next fiscal year.

IT IS EXPRESSLY PROVIDED that the WILLIAMSON-BURNET COUNTY OPPORTUNITIES, INC. will indemnify and hold Burnet County harmless for any of its acts, either by negligence or intentional torts, and that Burnet County does not accept any responsibility for the negligence of the WILLIAMSON-BURNET COUNTY OPPORTUNITIES, INC. personnel or any of its actions. The WILLIAMSON-BURNET COUNTY OPPORTUNITIES, INC. is an independent contractor and none of its actions or non-actions is governed by the Commissioners Court. Nothing in this Agreement shall require Burnet County or the Commissioners Court to renew this Agreement.

This Agreement contains the entire agreement between Burnet County and the WILLIAMSON-BURNET COUNTY OPPORTUNITIES, INC. and any modifications of this Agreement must be done in writing and be approved by the Commissioners Court in open session.

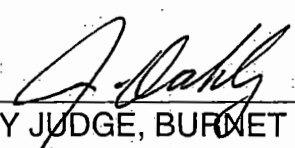
