Sheriff's and Constable's Fees year 2019

Add the following Fees and information.

***Note:** Pursuant to Rule 126 of the Texas Rules of Court, all fees for any and all civil cases originating outside the County of Burnet and/or the State of Texas must be collected in advance except when a Pauper's Oath is filed. The Sheriff or Constable will not execute any process until fees are received.

****Pursuant to Local Government Code, Section 118.131 and Attorney General Opinion (JM1046), the expenses for providing the services incident to unsuccessful service of process are equal to or exceed the expenses of actual service and the fee is thus set at the same cost charged for actual service. Fee covers three attempts to deliver process; addition attempts require additional service fee.**

*****A flat rate of \$35.00 per hour after the first 2 hours is required for an officer to perform a writ service to return from performing that service, from Burnet County to any other County or State and then return, using a Burnet County vehicle.**
