NOW, THEREFORE, BE IT RESOLVED THAT:

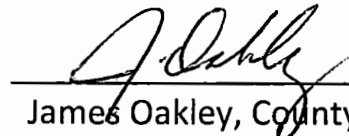

road equipment from the proceeds of tax-exempt obligations to be issued subsequent to the date hereof.

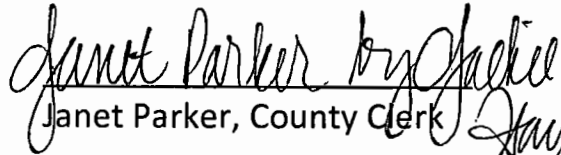
