Lot 5 is partially in Burnet County and Travis County. Last year, Travis County Commissioners Court cancelled Lots 1-4, Block "C" for the same owners of this Lot 5. The cancellation of Lot 5, Block "C" is currently proceeding through the Travis County Partial Subdivision Cancellation process.
