

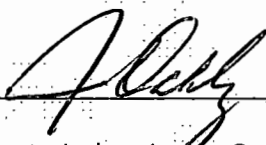

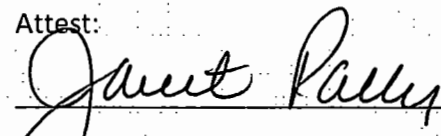
1. This approval is separate and distinct from the Inter-local Cooperation Contract itself.
