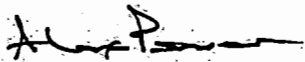

Thank you for sharing your proposed plan for the additions to your home and garage. You note that the diagonal line represents the building setback from the street and that you previously obtained a variance for the existing garage. Your garage addition appears to be within that required setback and so is in keeping with POA guidelines.

The plan does not show the lateral setbacks of your two contiguous properties but if you are indeed replatting Lots 21 and 22 as one, then we are confident that your garage addition will be within that required setback and so is in keeping with POA guidelines. As soon as available, please provide us with a copy of Burnet County's acceptance of your replat filing.
