Motor Vehicle Crime Prevention Authority Resolution

**2022 Burnet County Resolution
Motor Vehicle Crime Prevention Authority Grant Program**

WHEREAS, under the provisions of the Texas Transportation Code Chapter 1006 and Texas Administrative code Title 43; Part3; Chapter 57, entities are eligible to receive grants from the Motor Vehicle Crime Prevention Authority to provide financial support to law enforcement agencies for economic automobile theft enforcement teams and to combat motor vehicle burglary in the jurisdiction; and

WHEREAS, this grant program will assist this jurisdiction to combat motor vehicle burglary and theft; and

WHEREAS, Burnet County has agreed that in the event of loss or misuse of the grant funds, Burnet County assures that the funds will be returned in full to the Motor Vehicle Crime Prevention Authority.

NOW THEREFORE, BE IT RESOLVED and ordered that the County Judge James Oakley of this Burnet County is designated as the Authorized Official to apply for, accept, decline, modify, or cancel the grant application for the Automobile Burglary and theft Prevention Authority Grant Program and all other necessary documents to accept said grant; and

BE IT FURTHER RESOLVED that Burnet County Sheriff Calvin Boyd is designated as the Program Director and County Auditor Karin Smith is designated as the Financial Officer for this grant.
