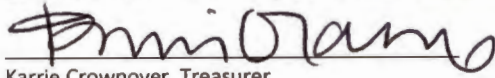


AFFIDAVIT

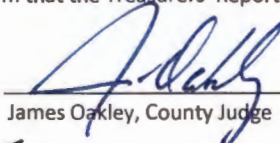

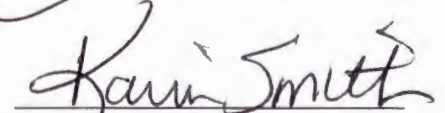
