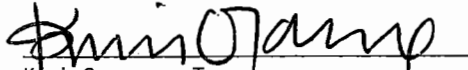


AFFIDAVIT

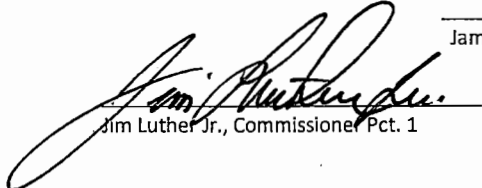

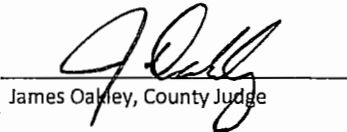

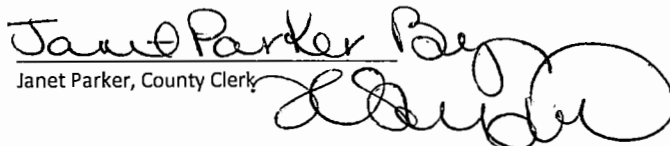
