WHEREAS, The Burnet County Commissioners' Court finds it in the best interest of the citizens of Burnet County that *the Burnet County Sheriff's Office* operate the Burnet County Crime Prevention Officer Program during October 1, 2024 – September 30, 2025; and

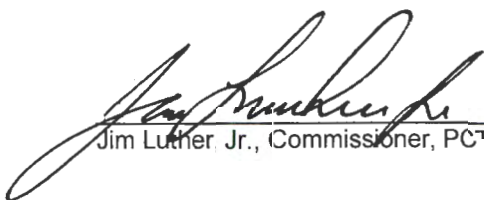
WHEREAS, The Burnet County Commissioners' Court agrees that in the event of loss or misuse of the Office of the Governor funds, The Burnet County Commissioners' Court assures that the funds will be returned to the Officer of the Governor in full.

WHEREAS, The Burnet County Commissioners' Court designates the Burnet County Judge as the grantee's authorized official. The authorized official is given the power to apply for, accept, reject, alter, or terminate the grant on behalf of the applicant agency.

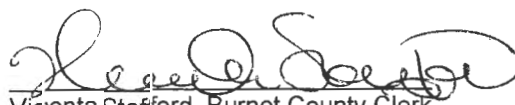
