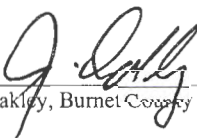
WHEREAS, Burnet County agrees to provide applicable matching funds for the said project as required by the FY 25 Bullet Resistant Shield Grant Program grant application; and

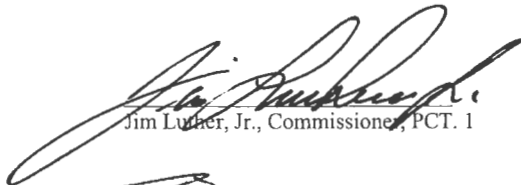
