WHEREAS, The County of Burnet finds it in the best interest of the citizens of Burnet County that the Women's Victim Advocate project be operated for the FY 25; and

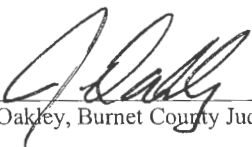

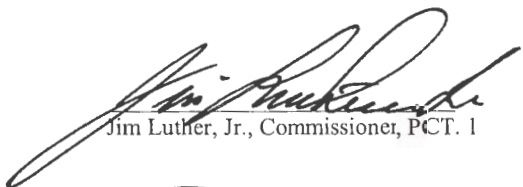

NOW THEREFORE, BE IT RESOLVED that Burnet County approves submission of the grant application for the Women's Victim Advocate project to the Office of the Governor.

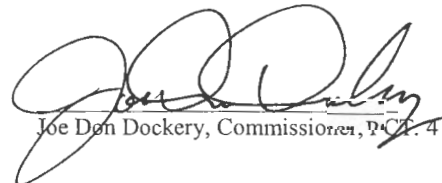
