Amendment No. 3 to Operating Agreement – Commissary Services

THIS AMENDMENT NO. 3 TO OPERATING AGREEMENT (the "**Amendment**"), is effective as of October 1, 2023, by and between the County of Burnet, Texas ("**County**"), and Aramark Correctional Services, LLC, a Delaware limited liability company, having its principal place of business located at the 2400 Market Street, Philadelphia, PA 19103 ("**Aramark**").

WHEREAS, on October 1, 2019, the parties entered into an Operating Agreement for the management of the commissary service operation at the Burnet County Correctional Facilities, (as amended, the "**Existing Agreement**");

WHEREAS, the parties previously agreed to extend the Term through September 30, 2023, and now desire to further extend the Term of the Agreement through September 30, 2024; and

WHEREAS, the parties desire to adjust the Product pricing set forth on the commissary menu. The Existing Agreement, as previously amended and further amended by this Amendment, is hereinafter referred to as the "**Agreement**". Capitalized terms used but not defined in this Amendment have the meanings ascribed to such terms in the Existing Agreement.

NOW, THEREFORE, in consideration of the foregoing and of the mutual promises set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. **Term:** In accordance with Section 5 of the Existing Agreement, the parties hereby agree to extend the term of the Agreement through September 30, 2024.
2. **Products and Pricing:** In accordance with Section 3 of the Existing Agreement, the parties hereby agree to adopt the Products and prices in Exhibit A, attached hereto, effective October 1, 2023, which shall replace the "Exhibit A" in the Existing Agreement or in any other prior agreements between the parties.
3. **Effect of Amendment; Entire Agreement:** Except as specifically set forth herein, all other terms and provisions of the Agreement shall remain unaffected by this Amendment and shall continue in full force and effect.
4. **Captions:** The captions in this Amendment are for convenience only and in no way define, limit or otherwise describe the scope or intent of this Amendment, or any provision hereof, or in any way affect the interpretation of this Amendment.
5. **Severability:** If any paragraph, subparagraph, sentence, clause, phrase, or portion of this Amendment is, for any reason, held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions of this Amendment.

6. **Counterparts:** This Amendment may be executed in one or more counterparts, each of which shall be deemed to be an original, but all of which shall be considered one and the same instrument. This Amendment, to the extent executed and delivered by electronic means (e.g. PDF emailed attachment), shall be treated in all manner and respects as an original agreement and shall be considered to have the same binding legal effect as if it were the original executed version thereof delivered in person.
