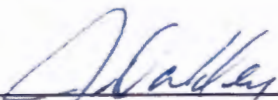

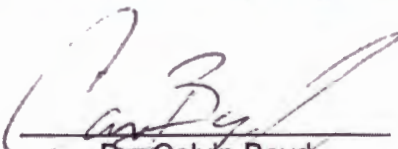
This Addendum is made to the Agreement between BURNET COUNTY and BLUEBONNET TRAILS COMMUNITY SERVICES approved in Commissioners Court on August 27, 2024, and now amended by mutual agreement by the parties as follows:

1. Contract Term Extension - The BLUEBONNET TRAILS COMMUNITY SERVICES's current contract with BURNET COUNTY shall extend until August 31, 2025.
2. Additional Funds: Not to exceed \$106,389.

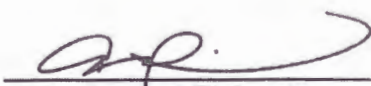
