CHAIRMAN RICK HEUMANN clarified the license is for wine tasting. He explained the kitchen is not a regular restaurant kitchen, it is used more for demonstrations or to make fudge and things like that.

COMMISSIONER EBERLE asked if the other location in Fulton Ranch is still open and recommended to visit as this additional location sounds like it will have the same layout and services.

VICE CHAIRMAN DAVID ROSE advised he is familiar with the other location and this is good use.
