If test positive, individual is safely relocated and housed in an isolation hotel where they still receive telephonic case management services until are healthy to enter My Sister's Place.

Arizona Coalition to End Sexual and Domestic Violence – Quarterly, the coalition hosts a community partner addressing domestic violence meetings. Upcoming and past trainings include Teen Dating Violence, Teens and Tech, Reproductive Justice series, and 40 Training.
