CALL TO ORDER:

The meeting was called to order at 5:06 PM by Michelle Hirsch via WebEx.

APPROVAL OF MINUTES FROM THE JANUARY 17 MEETING:

a) Peter sent the wrong attachment to the commission, so they were not able to preview the minutes. Peter will send the correct attachment before the March meeting, and the commission will approve it at that time.

- b) Peter shared that the downtown library project will require some additional funding. The library will pay for additional painting, and requested that the arts commission pay \$1000 for electrical work to provide for lighting. Tim made a motion to approve the funding. Farhana seconded the motion. The motion passed unanimously.

c) Peter shared a draft of the Tumbleweed Recreation Center RFQ. Commissioners suggested minor clarifying edits and a larger budget for finalists. Michelle Hirsch made a motion to approve the RFQ as amended. Julie seconded the motion. The motion passed unanimously.

- a) Ongoing public art projects
 - a. Peter shared photos of the updated INFLUX project. Michelle Hirsch asked if there was ever any feedback on the project, and Peter said he had received a few positive responses from the community. Tim suggested LED over neon for future projects of this sort, because they use less power and are still able to provide a variety of colors.
 - b. Peter shared that artist Egar Fernandez began priming the wall this past weekend, and plans to lead a community painting day this upcomiong weekend. The commission requested more information, which Peter will share after the meeting.
 - c. Peter shared that the downtown library project is moving along, and shared in-progress photos. The installation may be moved back to April, and Peter will keep the commission informed.
 - d. Peter shared photos of the downtown benches.
 - e. Peter shared that the Shumway project is also moving forward. Artist Miguel Godoy has been meeting with students. Michelle Hirsch shared that she thanked Councilmember Orlando for funding this project at the state of the city event.
- b) Maintenance Projects
 - a. Peter shared that he is still in the process of getting a complete quote for the museum shade structure repair.
