38. Introduction and Tentative Adoption of Ordinance No. 4992 Amending Chapter 14 of the City Code to Expand the Definition of Animal Cruelty and Allow Seizure of Animals When There is Evidence of Abuse

Move City Council introduce and tentatively adopt Ordinance No. 4992 amending Chapter 14 of the City Code to more specifically define animal cruelty; to include a new offense for animal hoarding; to strengthen the City's unlawful restraint law; to allow peace officers to seize animals for cruelty, hoarding, or unlawful restraint; to provide for the disposition of displaced animals; and to authorize post seizure hearings to determine the lawfulness of any seizure and forfeiture of any animal subjected to cruelty, hoarding, or unlawful restraint.

KELLY SCHWAB, City Attorney, presented the following presentation.

- City Code Chapter 14 Updates
- Timeline
- Police and Law departments began discussing potential Chapter 14 amendments several years ago
- May 2022 hearing held on animal seizure case in Chandler Municipal Court
 - Court Administrator provided input on the post-seizure hearing process to make it more consistent with best practices
- February 2023 August 2023 revisions were circulated for consideration and edits among the Law Department and Police Department
- August 2023 draft ordinance amending Chapter 14 was submitted to City Manager's office for initial review
- Outreach
- Staff provided draft Chapter 14 amendments to several animal welfare organizations for review and/or comment:
 - Arizona Humane Society (reviewed and commented; suggestions were considered and incorporated where appropriate)
 - Arizona State Veterinary Medical Examining Board (declined to comment)
 - o AZ Pet Project (commented on enforcement policies and their concerns were addressed)
 - o Maricopa County Animal Care and Control (reviewed, but declined to comment)
 - Arizona Animal Welfare League (declined to review)
 - PAC911 AZ Nonprofit Network of Animal Rescues (reviewed and commented)
- Posted on City website for public comment, received and reviewed.
- Current Challenges

- Current chapter 14 outdated language:
 - o Too narrowly defines animal cruelty
 - Does not adequately address the issue of animals seized for safekeeping purposes in non-cruelty cases
 - Current Code does not provide adequate regulations relating to the hoarding of animals in unsafe and/or unsanitary conditions
 - o Post-seizure hearings currently are based on State law and do not provide adequate procedures in addressing lawfulness of the seizure in Chandler Municipal Court
- Background
- City's role when an animal is seized
 - o Officer provides the owner of the animal with a Notice of Animal Seizure
 - Officer contacts Arizona Humane Society (AHS) to provide transportation, housing, and care for animals
 - o Officer files proof of services with the Chandler Municipal Court
 - Owner of the animal can contest the seizure in the Chandler Municipal Court
- Police response protocols
 - o Officers use Fourth Amendment principles for animal cruelty seizures
 - Consent to search exception requires consent from the property owner to enter the property
- Background
- Potential charges for different forms of abuse
 - o Common cases of animal cruelty are designated as class 1 misdemeanors
 - More serious cases of cruel neglect or abandonment resulting in serious physical injury to the animal are designated as class 6 felonies
 - Most serious cases of abuse such as intentionally or knowingly subjecting a domestic animal to cruel mistreatment is a class 5 felony

 - Failing to provide medical attention necessary to prevent unreasonable suffering

 - o Allow any dog to interfere, kill or cause physical injury to a service animal
- Add section on Animal Hoarding
 - If person possesses animals under circumstances injurious to the health or welfare of any animal
 - Abandonment
 - Unsanitary, overcrowded, other inhumane conditions
 - Failure to provided medical care
 - Failure to provide suitable water and necessary food appropriate for the species
- Proposed Changes
- Add Language to section on unlawful restraint of dog
 - Collar not properly fitted to the dog
 - Length is shorter than 10 feet
 - o Places the dog in unsafe or unsanitary conditions
 - Causes injury to the dog
 - o Does not allow dog to access food, water, shade and shelter
- Update language on authority to seize and impound animals subjected to cruelty
 - Peace officer has reasonable grounds to believe that very prompt action is required to protect the health or safety of the animal

COUNCILMEMBER HARRIS said the ordinance is a crucial step towards strengthening animal welfare laws in the city. The efforts address animal cruelty and emphasize the importance of providing basic amenities for dogs, including safe and clean parks, water fountains, and proper leash use. The city's investments in essential improvements to dog parks reaffirm their significance in promoting animal welfare and community benefits. Councilmember Harris expressed support for the ordinance and its continued progress.

COUNCILMEMBER ELLIS said that some community members have raised a valid concern about the lack of a shelter facility to house captured dogs. We need to partner with such facilities to ensure the welfare of the dogs that we encounter and capture. MS. SCHWAB said we have a contract with the Arizona Humane Society to assist us with animals in need. They provide transportation, care, and holding services, and we pay them for this. Our police department works closely with the Humane Society, and depending on how the animals are picked up, they may end up at the Maricopa County Animal Shelter.

COUNCILMEMBER ELLIS asked about the procedure for managing situations involving dogs. Specifically, they asked how the police and community partners work together to pick up dogs found on private property.

MS. SCHWAB said that we can contact our partner, the Humane Society Maricopa County Animal Control, for any issues related to animals in the county. They are usually available to respond, but if not, we can rely on some dedicated officers in our police force who can temporarily hold the animals until the Humane Society arrives.

COUNCILMEMBER ELLIS asked to partner with local nonprofits or individuals with relevant experience instead of relying solely on large organizations like the Human Society.

MS. SCHWAB said we have a contract directly with the Humane Society, the partner we are familiar with. I am unaware of any other partners, but to my knowledge, we exclusively work with the Humane Society.

VICE MAYOR ORLANDO said we need to clarify the language in certain sections, like 14-8 and 12, as the language is ambiguous, some of these sections date back to 1990. Vice Mayor Orlando requested that the staff review and amend those sections' language to ensure clarity.

MAYOR HARTKE said we can review and revise any other aspects that may require attention in the future. Our council has the advantage of frequent meetings, which allows us to address any necessary Charter amendments in a timely manner.

MS. SCHWAB said we have a team that is helping after hours. We also have an emergency animal clinic to assist with treating and caring for these animals.

MAYOR HARTKE added that we have the necessary tools to mediate situations effectively and respond promptly. Although there is always room for improvement, this is a place where we can acquire more tools to address hoarding and cruelty from the city's perspective.

MS. SCHWAB said we have worked with the police, prosecution, and courts involved in these cases. All three departments are comfortable with the tools at hand. We have a legal advisor and city prosecutor available 24/7 to provide guidance.

COUNCILMEMBER ENCINAS said we need to emphasize the accurate and aligned changes. We must revisit the outreach and gather input from animal communities, residents, and collaborating organizations. We need to ensure their support before finalizing the changes.

MS. SCHWAB said she does not have an exact number, but many community members agreed that the changes were good. Some individuals would like to see additional changes, but from an enforcement perspective, they were uncomfortable going further. However, after talking to most of the community, it was concluded that the changes are a good step in the right direction.

COUNCILMEMBER ENCINAS asked how long the public outreach period was open and how the information was disseminated.

MS. SCHWAB said that the ordinance was posted on the website immediately after the sub-committee meeting on October 23rd. The ordinance has been open for comments since then, and some comments have been received as recently as today. Our office and the police department reviewed these comments, and wherever we felt they could be incorporated, they were included as good suggestions.

COUNCILMEMBER ENCINAS said we proposed some language regarding special needs animals, such as equipment tools, and whether it falls under cruelty and asked if we are we addressing this in the proposed changes.

MS. SCHWAB said they did not specifically define special needs equipment but instead emphasized the importance of providing animals with appropriate medical care and treatment to prevent unnecessary suffering. This includes using special equipment if necessary to ensure that the animal is not causing harm to itself. Failure to use appropriate equipment for an animal could result in prosecution.

MAYOR HARTKE said there were comments about chickens, backyard turkeys, and animal cruelty in a recent Neighborhood Services meeting. They also mentioned a possible runaway sloth that is not allowed as an exotic animal. We need to identify any gaps in regulations regarding other animal species.

MS. SCHWAB said that under this ordinance, we can prosecute individuals for subjecting animals to cruel treatment or abuse.

COUNCILMEMBER STEWART thanked the subcommittee, animal rights groups, and the Police Department for creating an ordinance to help animals in need. Councilmember Stewart thanked the public for their support, asked for more education to help people understand its importance, and thanked City Attorney for her hard work.

COUNCILMEMBER ELLIS thanked everyone who worked on the project with such efficiency. Not only that but given the circumstances in our community, we prioritized and pushed this forward.

TERRI HOFFMAN, 6160 W. Gelding Dr., Glendale, AZ 85306, is opposed to item 38, and revisions must be made. Animal rights activists are concerned about current laws and advocate for better ones. Definitions in these laws are crucial and should be accurate. Law enforcement should also be trained on the appropriate use of probable cause. We must be mindful of animal welfare, and stray dogs should not be sold to medical research facilities. There are over 600 rescues in our community that can help.

COUNCILMEMBER HARRIS asked if the state law addresses issues not covered in this ordinance.

MS. SCHWAB said there are different laws for the state and some overlap with the city ordinances. There is no confirmation whether the state law addresses certain aspects that this ordinance does not cover. It is not possible for us to define felonies as that is something only the state can do. Additionally, I want to clarify that the city does not operate an animal shelter, but Maricopa County does. The animals are not being given away or sold for medical research by either Maricopa or the city. Some of our older code provisions contain archaic language, and the Vice Mayor has directed us to update it. The changes to this ordinance provide us with effective tools to address situations where animals are not being treated appropriately. We have worked closely with the courts, prosecution, and police to ensure the new provisions are effective.

COUNCILMEMBER HARRIS asked if it would be appropriate to include a link to the state constitution on animal cruelty and its definition on the Chandleraz.gov website. Although the city works with a group on this issue, adding a link to the State Statute near the website section where the information will be placed for future reference.

MS. SCHWAB said yes, that we can consider doing that.

COUNCILMEMBER HARRIS asked whether we could collaborate with our Police Department to provide adequate training on the proposed ordinance. This training will ensure that they understand the complexities and implications of the ordinance.

JOSH WRIGHT, City Manager, said whenever a new ordinance is passed that impacts the police department's operations, a training process is initiated to ensure everyone is knowledgeable about the law. The department also collaborates with external partners, such as the Humane Society, to ensure they understand the new system. This will also be the case with the new ordinance.

COUNCILMEMBER HARRIS asked if the training is continuous.

MR. WRIGHT said that is correct.

COUNCILMEMBER POSTON said the Police Department prioritizes training and reiterated that there was a good point made about addressing medical devices or specific health issues related to animals and wants to ensure that this matter is also taken into consideration as they move forward.

Mayor Hartke moved to introduce and tentatively adopt Ordinance No. 4992 amending Chapter 14 of the City Code to more specifically define animal cruelty; to include a new offense for animal hoarding; to strengthen the City's unlawful restraint law; to allow peace officers to seize animals for cruelty, hoarding, or unlawful restraint; to provide for the disposition of displaced animals; and to authorize post seizure hearings to determine the lawfulness of any seizure and forfeiture of any animal subjected to cruelty, hoarding, or unlawful restraint.; Seconded by Councilmember Stewart.

Motion carried unanimously (7-0).
