 - o The roof maintenance project is starting this month (June).
 - o A contractor for the HVAC project has been found. This project will not be at the same time as the roof maintenance.
 - $\circ\,\mbox{The fire}$ suppression system was recently cleaned and drained.
 - o The Drama Studio is being painted this week.
