Vice Chair Fagen asked if Ofc. Bebak-Miller was the only officer who was present for the shooting incident or if any other officers were involved. **Det. Ynclan** stated Ofc. Bebak-Miller was the only officer present. Officers responded after the shooting incident had occurred.

Panel member Wallace asked if the City of Chandler Police Department has a policy or procedure in pursuing non-violent or danger individuals who flee from Police. **Det. Ynclan** explained the policy and statute of flighting from an officer while in pursuit.

The findings of the investigation were approved by **all Panel members** present.

- c. **Review and discuss the Shooting Incident Summary of July 24th of 2021.**



