#### DISCUSSION

3. 2023 Community Needs Assessment.

Vice Chair Magel called on Ms. Balch to present information on this item.

Ms. Balch reported that the City of Chandler contracted Crescendo Consulting Group (Crescendo) to conduct the five-year update to the 2019 Community Needs Assessment. The goal of the update is to collect information about what has changed over the past five years to assist the city in determining how it can address the most pressing needs through the procurement of human services.

Ms. Balch introduced Mr. Kevin Koegel of Crescendo to facilitate a discussion to prioritize the needs identified through the assessment process. Mr. Koegel provided an overview of how the assessment was conducted and a summary of preliminary findings. The Commission reviewed identified needs and discussed how they might be ranked and grouped to best meet the needs of the community. After thorough discussion, the Commission requested for staff to prepare a framework reflecting their preferences for additional comment. Ms. Balch committed to sending a draft out for feedback. Final approval will occur at the November 8, 2023, Commission meeting.

#### **MEMBERS COMMENTS / ANNOUNCEMENTS**

Commissioner Tony Alcala announced the groundbreaking of the reimagined Galveston Elementary School that is being redesigned for the 21<sup>st</sup> century and will replace the original school built in 1963. The rebuilding of the campus is expected to be completed in October 2024.

Commissioner Tepper requested input from Commissioners on partnership opportunities for providing healthcare services to vulnerable populations in Chandler through Terros Health.

#### **RESOLUTION NO. 5752**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CHANDLER, ARIZONA, APPROVING THE INTERGOVERNMENTAL AGREEMENT BETWEEN MARICOPA COUNTY ADMINISTERED BY ITS HUMAN SERVICES DEPARTMENT AND THE CITY OF CHANDLER TO ACCEPT AMERICAN RESCUE PROGRAM FUNDS IN THE AMOUNT OF \$10,000,000, AUTHORIZING THE CITY MANAGER TO SIGN ALL RELATED DOCUMENTS AND ASSURANCES ON BEHALF OF THE CITY OF CHANDLER; AND FURTHER AUTHORIZING THE CITY MANAGER TO TAKE ALL ACTION NECESSARY OR PRUDENT TO IMPLEMENT THE CITY'S AFFORDABLE HOUSING PROJECTS

WHEREAS, Maricopa County, acting by and through the Maricopa County Human Services Department, ("MCHSD") notified the City of Chandler that it would receive \$10,000,000 of American Rescue Plan Act ("ARPA") funds, with \$5,000,000 to be used in support of the new construction of the Villas on McQueen and \$5,000,000, to be used in support of the new construction of Site 3 (73 S. Hamilton); and

WHEREAS, the City of Chandler and MCHSD desire to provide increased affordable housing opportunities in the City of Chandler; and

WHEREAS, the City of Chandler and MCHSD wish to execute an Intergovernmental Agreement ("IGA") to provide for use of the ARPA funds for the purpose of increasing affordable housing opportunities in the City of Chandler in accordance with ARPA requirements.

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Chandler, Arizona as follows:

- Section 1. Accepts the ARPA funds in an amount up to \$10,000,000 from Maricopa County acting by and through the MCHSD.
- <u>Section 2</u>. Authorizes the Mayor of the City of Chandler, or his designee, to execute the IGA with Maricopa County in substantially the approved form attached hereto as Exhibit "A" and incorporated herein by this reference.
- <u>Section 3</u>. Authorizes the City Manager, or his designee, to execute, on behalf of the City, appropriate certifications and other documents and take such other actions as are necessary or appropriate to carry out the intent of this Resolution, administer the ARPA funds in accordance with program requirements and implement the City's affordable housing projects.

#### **RESOLUTION NO. HO177**

A RESOLUTION OF THE PUBLIC HOUSING AUTHORITY COMMISSION OF THE CITY OF CHANDLER, ARIZONA AUTHORIZING THE CONVERSION OF VILLAS ON MCQUEEN THROUGH THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT'S RENTAL ASSISTANCE DEMONSTRATION AND SECTION 18 DISPOSITION PROGRAMS; AND AUTHORIZING THE CITY MANAGER OR DESIGNEE TO SIGN ALL AGREEMENTS AND RELATED DOCUMENTS ON BEHALF OF THE CITY OF CHANDLER AND/OR THE CITY OF CHANDLER PUBLIC HOUSING AUTHORITY.

WHEREAS, the Housing Authority of the City of Chandler, Arizona (the "Authority") proposes to convert 78 public housing units from 210 N. McQueen and 73 S. Hamilton to a newly constructed site named Villas on McQueen through a Rental Assistance Demonstration ("RAD")/Section 18 Disposition Blend as a way to preserve this site; and

WHEREAS, the Authority is eligible to apply for 60% of the units under the Section 18 Disposition program, with the remaining 40% converting through RAD under guidelines of PIH Notice 2021-07 Section 3.A.2.e. Blending Section 18 Disposition Approvals with RAD Conversion; and

WHEREAS, upon conversion to Section 8 Project Based Vouchers ("PBV"), the Villas on McQueen project will adopt the resident rights, participation, waiting list, and grievance procedures listed in RAD PIH Notice 2012-32, REV 4 and comply with other applicable governing PBV regulations.

NOW, THEREFORE, BE IT RESOLVED by the Public Housing Authority Commission of the City of Chandler as follows:

- <u>Section 1.</u> Approves and authorizes the conversion of 78 public housing units to Villas on McQueen PBVs through the RAD/Section 18 Blend and the proposed disposition of the Property described therein.
- <u>Section 2.</u> Authorizes the City Manager, his designee or the Authority's Housing and Redevelopment Senior Manager to execute all agreements and documents related to this conversion on behalf of the City of Chandler or the Authority.
