Proposed Motion:

Move the Public Housing Authority Commission pass and adopt Resolution No. HO174 approving and authorizing an amendment to the Consolidated Annual Contributions Contract between the U.S. Department of Housing and Urban Development and the Chandler Public Housing Authority for HUD-Veterans Affairs Supportive Housing (HUD-VASH); Authorizing the Housing and Redevelopment Division, as the City of Chandler's Public Housing Authority (Chandler PHA), to utilize funding associated with ten (10) VASH vouchers; and Authorizing the City Manager or Designee to sign agreements and all related documents on behalf of the City of Chandler.

Background:

On August 16, 2022, the U.S. Department of Housing and Urban Development (HUD) announced the availability of approximately \$79 million in HUD Veterans Affairs Supportive Housing (HUD-VASH) vouchers under PIH Notice 2022-26 (HA). These vouchers are administered in partnership with the U.S. Department of Veterans Affairs (VA) and enable homeless veterans and their families to access affordable housing with an array of supportive services. HUD-VASH is authorized under section 8(o)(19) of the United States Housing Act of 1937, as modified by the requirements in the Consolidated Appropriations Act, 2022 (Public Law 117-103, approved March 15, 2022) (the Act). The HUD-VASH program combines HUD Housing Choice Voucher (HCV) rental assistance for homeless veterans

with case management and clinical services provided by Veterans Affairs (VA) at its medical centers (VAMC) and community-based outpatient clinics (CBOCs) or by VA contractors or VA designated entities.

Discussion:

The City of Chandler Public Housing Authority (Chandler PHA) applied for VASH allocation on September 16, 2022, and received a letter of support from Phoenix VA. On December 22, 2022, HUD notified the Chandler PHA of an award of ten (10) VASH vouchers to be administered in partnership with the VA Medical Center/V22 Phoenix to serve veterans in the City of Chandler. The Agency Plan developed incorporates the Housing Choice Voucher Program policies and lease forms utilized to implement ten (10) VASH vouchers as part of the Chandler PHA Program. VASH vouchers are administered in partnership with the VA Medical Center to serve veterans in the City of Chandler. Veterans are referred to the Chandler PHA by the VA Medical Center/V22 Phoenix through its medical centers and community-based outpatient clinics or by VA contractors or VA designated entities. The VA is responsible to screen homeless veterans to determine whether they meet VASH program participation criteria and refers eligible homeless veterans to the Chandler PHA. VASH vouchers will help provide veterans with immediate access to permanent housing. HUD-VASH program is administered in accordance with regular HCV program requirements. The City currently administers 495 housing choice vouchers (Section 8 vouchers) and administers no VASH vouchers at this time.

Financial Implications:

HUD funds the costs associated with the HUD-Veterans Affairs Supportive Housing (HUD-VASH). HUD budget authority for VASH program is \$140,650.41 annually. These HUD-VASH vouchers will be included in the City's ongoing voucher count going forward.

Dear Executive Director:

I am pleased to notify you that your public housing agency (PHA) has been awarded funds from HUD-Veterans Affairs Supportive Housing (HUD-VASH) awards under Notice PIH 2022-26 (Registration of Interest for HUD-VASH Vouchers). These vouchers should be administered in partnership with the VA Medical Center listed below to serve veterans in your jurisdiction. With your direct effort, these vouchers will help provide veterans with immediate access to permanent housing. This letter provides the details of the funding awarded and information concerning the disbursement of these funds.

The enclosed table (see last page) shows the number of units and the budget authority awarded. If your agency wishes to decline this award, please reply to VASH_ROI@hud.gov by noon (EST) December 30, 2022, or they will be deemed accepted. The default effective date of your award will be February 1, 2022, unless you contact VASH_ROI@hud.gov by January 18, 2023, to request an alternative effective date. Your effective date may be the first of any month beginning February 2023 through June 2023.

Please remember, as with the regular voucher program, the awarded budget authority and number of units both serve as a cap. Your agency may only lease until you have reached the lower of your budget authority or number of units allocated. If you have money left but you have leased all the awarded units, this extra funding will go into your agency's HUD-VASH Housing Assistance Payment (HAP) reserves. If you are on track to spend all of the awarded funding but still have units left, you must manage your funds in a responsible manner that will not result in a shortfall.

The Financial Management Center (FMC) will provide your agency with an amended Annual Contributions Contract that reflects the obligation of funds and monthly disbursements amount to be scheduled. Initially, the first three months of disbursements will be automatically scheduled. Each disbursement will equal 1/12th of your award amount. Thereafter, monthly disbursements will be scheduled based on monthly HUD-VASH expenses reported in the Voucher Management System (VMS). If you have not leased any vouchers by month three, you will not receive additional disbursements until VMS data shows you are incurring HAP expenses. If at any time such disbursements are not sufficient to cover your monthly expenses, your agency should contact your Financial Analyst at the FMC.

Your PHA is required to follow relevant statutes, regulations, and HUD guidance when administering the HUD-VASH Program, including the regulations at 24 CFR part 982, and the requirements in PIH Notice 2022-26 and the guidance set forth in Section 8 Housing Choice Vouchers: Revised Implementation of the HUD Veterans Affairs Supportive Housing Program published in the Federal Register on September 27, 2021.

To ensure that HUD-VASH families are recorded properly, you must record "VASH" on line 2n of the form HUD-50058 (Family Report). Remember to accurately record families who are homeless at admission on line 4c of the HUD-50058. HUD-VASH vouchers and corresponding HAP expenses must also be accurately reported in VMS.

A RESOLUTION OF THE PUBLIC HOUSING AUTHORITY COMMISSION OF THE CITY OF CHANDLER, ARIZONA, APPROVING AND AUTHORIZING AN AMENDMENT TO CONSOLIDATED ANNUAL CONTRIBUTIONS CONTRACT BETWEEN THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT AND THE CHANDLER PUBLIC HOUSING AUTHORITY FOR HUD-VETRANS AFFAIRS SUPPORTIVE HOUSING; AND AUTHORIZING THE HOUSING AND REDEVELOPMENT DIVISION AS THE CITY OF CHANDLER PUBLIC HOUSING AUTHORITY TO UTILIZE FUNDING ASSOCIATED WITH TEN VASH VOUCHERS; AND AUTHORIZING THE CITY MANAGER OR DESIGNEE TO SIGN AGREEMENTS AND ALL RELATED DOCUMENTS ON BEHALF OF THE CITY OF CHANDLER AND/OR THE CITY OF CHANDLER PUBLIC HOUSING AUTHORITY.

WHEREAS, on August 16, 2022, U.S. Department of Housing and Urban Development (HUD) announced the availability of approximately \$79 million in HUD Veterans Affairs Supportive Housing (HUD-VASH) vouchers under PIH Notice 2022-26 (HA). These vouchers are administered in partnership with the U.S. Department of Veterans Affairs (VA) and enable homeless veterans and their families to access affordable housing with an array of supportive services; and

WHEREAS, HUD-VASH vouchers are authorized under section 8(o)(19) of the United States Housing Act of 1937, as modified by the requirements in the Consolidated Appropriations Act, 2022 (Public Law 117-103, approved March 15, 2022) (the Act). The Act provides \$50 million in funding for the vouchers being made available under PIH Notice 2022-26 (HA). The additional \$29 million in funding is available from prior year appropriations; and

WHEREAS, The HUD-VASH program combines HUD Housing Choice Voucher (HCV) rental assistance for homeless Veterans with case management and clinical services provided by the VA at its medical centers (VAMC) and community-based outpatient clinics (CBOCs) or by VA contractors or VA designated entities. The VA facility refers all eligible HUD-VASH families to the appropriate public housing authority; and

WHEREAS, on December 22, 2022 HUD notified City of Chandler Housing and Redevelopment, as the City of Chandler Public Housing Authority (PHA), of an award of ten (10) VASH vouchers to be administered in partnership with the VA Medical Center/V22 Phoenix to serve veterans in the City of Chandler. The City's Agency Plan incorporates the HCV Program policies and lease forms utilized to implement 10 VASH vouchers as part of the City of Chandler Housing Program.

NOW, THEREFORE, BE IT RESOLVED that the Public Housing Authority Commission of the City of Chandler, Arizona:

Section 1. Approves and authorizes an Amendment to the Consolidated Annual Contributions Contract between HUD and the PHA, in accordance with the award letter attached hereto, as well as the documents and authorities incorporated therein.

Section 2.	Authorizes the City Manager, or designee, to accept additional VASH vouchers if such become available on behalf of the PHA and the City of Chandler.				
Section 3.	Authorizes the City Manager, or designee, to sign agreements and all related documents on behalf of the PHA and the City of Chandler.
