**Improvements**

### Additions

Mr. Povar suggested adding US or military flags at the entrances, similar to nearby neighborhoods. Comm. Levinson recommended adding unique touches to the event to draw a larger audience, such as including military vehicles. Vice Chair Simon suggested moving the event to an earlier date to avoid conflicts with other events. Mr. Povar advised he would investigate the cost of a drone show as a potential addition. Chair Farabee noted that she has an Air Force contact in Tucson who might be able to assist.

The Commission agreed that the event well, highlighting the quilts being raffled off and the food provided.
