 - 0.5 FTE Client Resources Representative
- Relocation Assistance
 - Support for up to 80 households from public housing
 - Moving to The Haven on Hamilton (Fall 2027)
- President's Proposed FY 2026-2027 Budget
 - HOME-Funded Programs at Risk
 - Tenant-Based Rental Assistance (TBRA) Program
 - Rental assistance for up to 24 months per household
 - Currently supporting 25 households
 - No capacity to add new clients without additional funding
 - Public Housing Redevelopment (RAD) Projects
 - HOME funds for Gap Financing
 - Assists low-income households
- President's Proposed FY 2026-2027 Budget
 - Rental Assistance Programs at Risk
 - Housing Choice Voucher (HCV)
 - 43% funding reduction approximately 214 impacted households
 - Impact to landlords accepting vouchers
 - Public Housing
 - Reduced ability to operate City-owned housing sites
 - Potential forced sale of scattered sites
 - Significant reduction of multi-family sites
 - Family Self-Sufficiency Program elimination
 - Would impact 120 Chandler households annually
- Policy Change Impacts
 - Current and Proposed
 - Difficult to Develop Areas (DDA)
 - Previous DDAs have lost their designation and will no longer qualify for LIHTC funding
 - No process to be granted an exception
 - o Emergency Housing Vouchers
 - City administers 28 Emergency Housing Vouchers
 - Program funding will be exhausted December 2026 (not 2030)
 - Awaiting guidance on absorbing these vouchers into HCV program
 - Additional Policy Changes (Proposed in President's Budget)
 - Two-year assistance cap for all able-bodied adults
 - Would impact over 550 Chandler households
- Other Issues
 - o VASH Vouchers

- VA terminated VASH voucher for Chandler household for non-participation in case management. Voucher shouldn't have been terminated while PHA was on shortfall.
- Chandler was unable to transfer Veteran to HCV because:
 - HUD believes Veteran must be on waitlist
 - HUD believes termination makes Veteran ineligible for HCV
- Chandler stepped in with case management and landlord engagement to keep Veteran housed, but Veteran now owes approximately \$20,000 because no subsidy is in place
- VA will only reinstate VASH voucher if Veteran gets a payee which requires rating of "incapacitated" VA doctor does not support.
- HUD asked city to request waiver of requirement for Veteran to be on waitlist but will not backdate subsidy should they approve
- Chandler working with Veteran intensively on case management and payback plan for Veteran portion.
