Public Hearing

14. Chandler General Plan Update, PLH25-0010, Public Input, Consideration and Discussion Regarding the Update of Chandler's General Plan - Continued to the Monday, February 23, 2026 Special Meeting Unscheduled Public Appearances

Unscheduled Public Appearances

JENNY VITALE, Chandler, AZ, spoke regarding the city's retention basin project. She stated that the project has faced ongoing challenges, particularly due to the failure to complete proper analysis before design and construction. As a result, the basins were landscaped before drainage and drywell were tested. Ms. Vitale emphasized the importance of analysis and construction and called for better training to ensure projects are built in the correct order and properly supervised. She also expressed concern with the project's aesthetics, noting that the gray rock used does not match the surrounding neighborhoods. She acknowledged staff's willingness to work with her on solutions and urged the city to hold the rock supplier accountable and ensure aesthetics are maintained on city projects.

ROHITH CHANDRASHAKER, 800 W. Oakland St., Chandler, AZ, spoke expressing concerns about the City's use of Flock Safety's ALPR technology. He stated that the agreement may conflict with Council's statement that policing and immigration enforcement should not overlap. While commending the Council's intent, he questioned whether the city has fully upheld that commitment. Mr. Chandrasher said he has not received clear answers on whether Chandler opted in or out of federal data sharing through Flock, nor has he been provided with a copy of the city's privacy agreement. He alleged that Flock has shared data with federal agencies despite prior denials and that Chandler's data has been accessed outside Arizona through intercity and interstate sharing. He further stated that data may be accessible to 287G Jail Enforcement

program jurisdictions, including Mesa, and urged the city to suspend or reevaluate its agreement with Flock in light of ongoing privacy concerns raised by other municipalities.

MAYOR HARTKE asked staff to address the questions raised and clarify the city's current data-sharing practices.

VICE MAYOR ENCINAS stated that he requested a review of the city's Flock services and asked that the results be shared with Council once completed.

JOHN POMBIER, City Manager, shared that the results will be provided.

GEORGE RITCHIE, 44611 Pecan Dr., spoke about two concerns. He stated that he moved to Ocotillo in 2008 and wished to address issues related to the city's hazardous materials recycling center and noise from the Intel facility near Dobson and Ocotillo. Recently, after changing his vehicle's antifreeze, he attempted to dispose of it at the Chandler Recycling Center but was turned away because he did not have an appointment. He described the policy as unreasonable and said hazardous waste recycling should be simple, free, and encourage proper disposal. He urged city leadership to review the center's operations and implement stronger oversight and performance standards. Mr. Ritchie also reiterated concerns he had previously raised about noise from the nearby Intel plant. He said the noise affects a wide area, including neighborhoods between Dobson, Alma School, Ocotillo, and Chandler Heights. According to him, loud steam bursts penetrate homes and disrupt residents. Although the city has stated the plant is in compliance with regulations, he disagrees and, as an engineer, believes the noise measures are taken under conditions that minimize how far sound travel and do not reflect typical conditions.

COUNCILMEMBER ORLANDO suggested reviewing the recycling center's household hazardous waste appointment reservation policy during the next budget cycle, noting resident concerns and personal inconvenience. He also recommended exploring whether Intel could help identify and mitigate related issues.

NOAH JAMES MARKHAM, Tempe, AZ, spoke about his desire for more nightlife options in downtown Chandler, suggesting the addition of a restaurant and club that would appeal to both young adults and Gen Z residents. He also encouraged the city to further celebrate diversity, including the possibility of a Pride parade. Additionally, he expressed support for Chandler students opposing ICE and stated his opposition to ICE and President Donald Trump being present in Chandler.

Current Events

Mayor's Announcements

MAYOR HARTKE recognized the airport team for last month's Airport Day, which drew nearly 15,000 attendees and offered a behind-the-scenes look at one of the nation's busiest general aviation airports. He thanked the team and the community for their support.

MAYOR HARTKE congratulated Dr. Anna Battle on her appointment as Chandler Unified School District superintendent, noting her nearly four decades of educational leadership and the community's anticipation of continued partnership to support student success.

MAYOR HARTKE invited the public to next Thursday's State of the City at the Center for the Arts, with a 5:30 p.m. reception and 6:30 p.m. remarks highlighting community achievements, challenges, and plans for 2026. More information and RSVP details are at chandleraz.gov/stateofthecity.

MAYOR HARTKE recognized the Chinese New Year, beginning February 17 and marking the Year of the Horse. He wished all who celebrate a year of health, happiness, and prosperity, and expressed gratitude for Chandler's diverse cultures and traditions.

Council's Announcements

COUNCILMEMBER POSTON shared last Friday's Downtown Developer Summit, highlighting the keynote by Jim Hyde and a panel of local developers. She recognized staff for completing the updated Downtown Regional Area Plan, which modernizes zoning to support redevelopment and allow Chandler to grow. She called the event impressive and exactly what the city needs.

COUNCILMEMBER POSTON recognized staff, noting that after Council received an email from a resident about stickers on light poles, Neighborhood Preservation and Street Maintenance staff went above and beyond by walking the streets to remove them. She stated that these efforts help keep the community clean and reflect the "Chandler way." She thanked the teams for their dedication and excellent work.

COUNCILMEMBER ELLIS recognized CE Precision Assemblies for expanding its Chandler operations with a nearly 40,000-square-foot facility on the west side of the city. She thanked the company for its long-standing presence, job creation, and contribution to Chandler's advanced and aerospace manufacturing sector.

COUNCILMEMBER ELLIS shared news that Yo Pauly's New York Pizza will be opening in Chandler. She invited the public to attend the grand opening and ribbon cutting on Monday, February 9, National Pizza Day, at 3:00 p.m., and encouraged the community to join in celebrating the new business.
