

RESOLUTION NO. 6033

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CHANDLER, ARIZONA, DECLARING THE OFFICIAL CANVASS OF RESULTS FOR THE CITY OF CHANDLER PRIMARY ELECTION HELD ON JULY 21, 2026.

WHEREAS, pursuant to Article VII, Section 7.01 of the Chandler City Charter, the City of Chandler, Arizona, held a Primary Election on July 21, 2026, for the purpose of electing a mayor and three Councilmembers; and

WHEREAS, A.R.S. § 16-642 requires that the City Council canvass the returns of the election no later than twenty (20) days following the election; and

WHEREAS, the City Council, having canvassed the returns of the July 21, 2026, Primary Election, pursuant to Arizona Revised Statutes § 16-646, finds the returns to be as stated in this resolution;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Chandler, Arizona, as follows:

Section 1. That Exhibit A, attached, is declared and adopted as the official canvass of votes of the July 21, 2026, Primary Election and includes:

1. the overall citywide voter turnout;
2. the number of ballots cast in each precinct and in the city;
3. the number of ballots rejected in each precinct and in the city;
4. the titles of the offices voted for, and the names of each person voted for to fill the offices;
5. the number of votes by precincts and city received by each candidate and the overall percentage of votes received by each candidate.

Section 2. That, as shown in Exhibit A, the total number of ballots cast in the July 21, 2026, Primary Election was 45,198. The total number of registered voters was 161,573, resulting in a 28% voter turnout rate.

Section 3. That the names of the candidates voted for at the July 21, 2026, Primary Election for the office of Mayor were:

Jeff Weninger

Section 4. That Matt Orlando, having received, at the July 21, 2026, Primary Election, a majority of all the votes cast for the office of Mayor, is declared to be elected to that office, and is hereby issued a certificate of election.

Section 5. That the names of the candidates voted for at the July 21, 2026, Primary Election for the office of City Councilmember were:

- Section 6. That Jane Poston, Angel Encinas, and Cicely Rocha-Miller, having received, at the July 21, 2026, Primary Election, a majority of all the votes cast for the office of Councilmember, are declared to be elected to those offices, and are hereby issued certificates of election.
- Section 7. That Proposition 415 – Proposed Ratification of the 2026 Chandler General Plan was approved by a vote of 32,446 yes votes to 6,207 no votes.
- Section 8. That the City Clerk shall enter Exhibit A on the records of the City of Chandler as the official canvass.
