

**PROCEEDINGS OF THE COCHISE COUNTY BOARD OF SUPERVISORS
REGULAR BOARD MEETING HELD ON
TUESDAY, JUNE 21, 2011**

A regular board meeting of the Cochise County Board of Supervisors was held on Tuesday, June 21, 2011 at 10:00 a.m. in the Board of Supervisors' Hearing Room, 1415 Melody Lane, Building G, Bisbee, Arizona. In attendance were Patrick Call, Chair; Ann English, Vice-Chairman; Richard Searle, Supervisor; Michael Ortega, County Administrator; Jim Vlahovich, Deputy County Administrator; Britt W. Hanson, Chief Civil Deputy County Attorney; and Katie Howard, Clerk of the Board.

Chairman Call called the meeting to order at 10:00 a.m.

Chairman Call explained that there was a correction to item 11. The total is \$11,150: \$10,700 in parcel/units sales and \$450.00 in administrative fees.

PRESENTATION

1. Brief presentation by Ms. Kathleen Gomez--Arizona Rural Chambers of Commerce Introduction to the Board of Supervisors

Ms. Gomez read a letter of introduction: In early 2010, seven Chambers of Commerce formed a Southeastern Arizona Rural Alliance to coordinate issues particular to the southeast corner of Arizona, which she listed. She said she would like to meet with the Board to discuss how to better coordinate a mutual effort. She introduced the members who were present and said they will have a collaborative booth at the Cochise County Fair this year. She is hoping this effort is a positive force for tourism, or for people who want to relocate to the county and for economic development efforts.

Vice-Chairman English stated that it might be good to explore development of a travel CD.

Ms. Gomez stated that they are working with the tourism council and their efforts would be also directed at educating folks in Phoenix about the challenges faced by rural, border counties.

Chairman Call said he looked forward to working with them.

10. Adopt Resolution 11-27 authorizing the submission of applications for FY 2011 State Community Development Block Grant Funds.

Ms. Patty Lewis, Grants Administrator presented this item. Ms Lewis said right after the May 26th Work Session the monetary award was distributed. \$267,443 is available to Cochise Country through the SouthEastern Arizona Governments Organization (SEAGO) rotational fund. She stated the amounts of the grants to be awarded: Emergency Home Repair Program, \$140,000; Fry Fire Station Improvements \$51,000; Bowie Fire District Extrication Equipment \$62,952; and County Administration \$13,491. The applications are due to SEAGO by July 1, 2011.

Chairman Call opened the public hearing.

No one wished to address the Board and Chairman Call closed the public hearing.

Supervisor Searle said he was frustrated by the guidelines that came down from the State that eliminated several worthwhile projects in the County.

Supervisor Richard Searle made a motion to adopt Resolution 11-27 authorizing the submission of applications for FY 2011 State Community Development Block Grant Funds. Vice-Chairman English seconded the motion.

Chairman Call called for the vote; approved 3-0.

Ms. Howard reported and explained the correction to the administrative fees from \$600 to \$450. She said these OTC sales, if approved, when added to the Auction proceeds of \$80,900 equal a year-to-date total of \$92,050 in sales and it puts over 1,700 parcels back on the tax rolls.

Vice-Chairman English amended the motion to reflect administrative fees of \$450. Supervisor Searle seconded the amended motion.

Mr. John Kumiega, bidder number three, offered \$1,101 as a counter bid for Unit ID 303.

Vice-Chairman English amended the motion to reflect unit #303 sold at \$1,101 to bidder number three and the total parcel sales amount was changed to \$10,701. Supervisor Searle seconded the amended motion.

Ms. Howard stated that if bidder number three has not purchased another property under the OTC sale, we will charge the customary \$75 administrative fee.

Chairman Call called for the vote; approved 3-0.

Ms. Patty Lewis, Grants Administrator presented this item. Ms. Lewis said Amendment #13 will compensate Stantec Consulting for additional services provided to complete the project for the engineer's job site inspections and the consultant's additional design concepts.

Supervisor Searle confirmed that the project is complete and operational.

Chairman Call called for the vote; approved 3-0.

Human Resources

15. Approve one paid day off incentive for Cochise County employees who participate in all applicable CCT sponsored wellness events in a fiscal year and direct staff to incorporate in policy.

Vice-Chairman English made a motion to approve one paid day off incentive for Cochise County employees who participate in all applicable CCT sponsored wellness events in a fiscal year and direct staff to incorporate in policy. Supervisor Searle seconded the motion.

Mr. Ortega presented this item and said the issue is simple; as the County went through the screenings last year, we discovered many illnesses that were unknown to the person; those identified were caught early and treated. If these conditions were left to progress, it becomes more expensive to treat and can be debilitating. This is a way to provide incentive to employees to participate in all screenings applicable to their demographic. He said the County will need two to three year's timeframe to provide data regarding savings to the Trust. There is not a tracking system because of HIPPA, but we do know that there are significant costs to the system from cancers and other disorders that go undetected as illustrated in the chart provided.

Chairman Call called for the vote; approved 3-0.

Indigent Defense

Mr. Ortega presented this item and said there are two capital cases facing the County today and he expects the County will spend about \$1.0 million each by the time they are settled. Ms. Udall has agreed to partner with Pima County and will be lead chair; Pima County will be second chair with the hopes that this will help to reduce the County's costs.

Chairman Call called for the vote; approved 3-0.

17. Approve the transfer of funds in the amount of \$150,000 from General Fund Contingency Account to Indigent Defense Coordinator (IDC) budget lines.

Mr. Ortega presented this item and said this is a separate capital case. The County had a bill before the state in excess of \$200,000 for a 50% reimbursement, but those funds were swept. He stated we need to transfer funds from contingency to cover the bills for this year.

This year's contract includes a modest increase for only the category of fewer than 20,000 meals per month; all other provisions of this contract remain the same and this is a reasonable request because of the rising costs of food.

Chairman Call called for the vote; approved 3-0.
