A regular board meeting of the Cochise County Board of Supervisors was held on Tuesday, October 9, 2012 at 10:00 a.m. in the Board of Supervisors' Hearing Room, 1415 Melody Lane, Building G, Bisbee, Arizona. In attendance were Richard Searle, Chairman; Patrick Call, Vice-Chairman; Ann English, Supervisor; Michael Ortega, County Administrator; Britt Hanson, Chief Civil Deputy County Attorney; and Arlethe Rios, Assistant to the Clerk of the Board.

Chairman Searle called the meeting to order at 10:00 a.m.

ROLL CALL – All three supervisors present.

PRESENTATION

Presentation of Certificates to Tim Zimmerman, Brian Adamson, Rosa Lopez and Travis Cutright of the Information Technology Department and to David Noland of the Cochise County Sheriff's Office in recognition of their work to place a repeater at Antelope Pass, thereby establishing radio coverage for the greater Portal area.

Chairman Searle presented certificates to all the recipients and stated that he was very pleased to see this agreement approved.

Supervisor English noted that this project had been ongoing for many years and she was happy to see it completed.

The Board members congratulated all the recipients for their hard work and dedication to getting the Public Safety Officers the technology they needed to better serve the citizens of Cochise County.

Ms. Arlethe Rios, Assistant to the Clerk of the Board presented this item. Ms. Rios said the Sheriff's Office and Planning and Zoning Department have recommended approval and the Environmental Health Division noted that the establishment meets all the requirements set forth by the Arizona Food Code; the Treasurer's Office has noted that all property taxes are current. The applicant has paid the \$100 processing fee; there are no known formal protests and staff is recommending approval.

Chairman Searle opened the public hearing. No one else wished to address the Board and Chairman Searle closed the Call to the Public.

Supervisor English made a motion to approve a new liquor license application for a series #13 (domestic farm winery) liquor license submitted by Mr. Mark W. Beres for Flying Leap Vineyards located at 5051 E. Flying Leap Way, Willcox, 85643. Vice-Chairman Call seconded the motion.

Chairman Searle called for the vote and it carried 3-0.

ACTION

10. Pursuant to A.R.S. § 16-230.A.2. Discussion and possible action to appoint a person to fill the remaining portion of Larry Dever's term of office as Cochise County Sheriff.

Mr. Mike Ortega, County Administrator presented this item. Mr. Ortega stated that pursuant to the statute, the Board shall appoint a person to fill the remaining portion of Larry Dever's term of office. He said that according to the County Attorney's Office there is not a date by when this has to be done, therefore the Board does not have to appoint anyone at this time. Mr. Ortega clarified that whoever is elected in the November election will not take office until January 2, 2013.

Supervisor English stated that it was the responsibility of the Board to appoint someone to finish the current term and said that although the next election was close, appointing someone was the Board's duty. She noted that Chief Deputy Rod Rothrock was doing an excellent job and should be appointed to Sheriff.

Supervisor English made a motion to appoint Chief Deputy Rod Rothrock to fill the remaining portion of Larry Dever's term of office as Cochise County Sheriff. Vice-Chairman Call seconded the motion.

Vice-Chairman Call stated that the Board was not under a time constraint. He noted that the department is being run well by the chief deputy. He felt that appointing someone at this time might be construed as support for one candidate over another since the chief deputy is running for Sheriff.

Chairman Searle noted that Chief Deputy Rod Rothrock has done an excellent job and has been for many years. He felt like the Board did not need to take action to help keep the continuity in the Sheriff's Office and that the citizens would decide who they wanted for Sheriff in three weeks.

Supervisor English reiterated that it was the Board's responsibility to appoint someone for the remainder of the term. She recognized Chief Deputy Rod Rothrock's competency in running the department. She clarified the difference between the Board appointing someone to finish the current term and the citizens electing a new Sheriff.

Chairman Searle called for the vote and it failed 2-1; English in favor.
