Dear Property Owner(s):

Our office received a request to investigate a violation of the Cochise County Hazard Abatement Ordinance on this parcel. Pursuant to this request, we performed an on-site inspection of the property and observed the following:

- OUTDOOR STORAGE OF TIRES-METAL-FURNITURE-CARS-JUNK-TRASH

We conclude that there is probable cause to believe that both of these conditions are hazards to public health and safety and, therefore, constitute a public nuisance. This serves as your official notice that you are in violation of the Hazard Abatement Ordinance.

The specific action(s) to correct the hazard(s) are:

- REMOVE ALL OUTDOOR STORAGE OF TIRES-METAL-FURNITURE-CARS-JUNK-TRASH IN A LEGAL MANNER.

You must dispose of any material at an appropriate waste collection facility or by other legal means and provide us with an affidavit attesting that the material was disposed of in a legal manner.

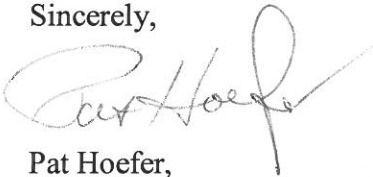
You must do this within thirty (30) days from the date of the postmark of this letter. In thirty days, the Hazard Abatement Officer will inspect the property to determine compliance. If you fail to remove and/or repair the hazards, Cochise County may at your expense remove and/or repair the hazard. The estimated cost for the County to remove and/or repair the hazards is \$160,000.00. However, the cost that would be charged would be the actual cost, which includes the time of County personnel assessed at the applicable rates. Further, the costs of removal/repair will be assessed upon the property and will be a lien on the property until the assessment is paid in full.

These conditions also constitute a Class 1 misdemeanor and may be subject to criminal penalties in addition to the cost of abatement.

If you disagree with the determination that the conditions cited above constitute hazards, you have the right to file a written appeal the Cochise County Board of Supervisors. The written appeal must be filed with the Clerk of the Board, at 1415 Melody Lane, Building G, Bisbee, Arizona 85603, within thirty (30) days of the date [of the postmark of this letter] [this letter is served on you].

Please understand that this Department is seeking your cooperation in correcting the Hazard violation(s).
