

**PROCEEDINGS OF THE COCHISE COUNTY BOARD OF SUPERVISORS
REGULAR BOARD MEETING HELD ON
TUESDAY, APRIL 9, 2013**

A regular board meeting of the Cochise County Board of Supervisors was held on Tuesday, April 9, 2013 at 10:00 a.m. in the Board of Supervisors' Hearing Room, 1415 Melody Lane, Building G, Bisbee, Arizona. In attendance were Ann English, Chairman; Richard Searle, Vice-Chairman; Patrick Call, Supervisor; Mike Ortega, County Administrator; Jim Vlahovich, Deputy County Administrator; Britt Hanson, Chief Civil Deputy County Attorney; and Arlethe Rios, Assistant to the Clerk of the Board.

Chairman English called the meeting to order at 10:00 a.m.

CALL TO THE PUBLIC

Chairman English opened the Call to the Public.

Mr. William Jacoby addressed the Board on issues dealing with permits issued by the Community Development Department and shared his ideas on how to better educate the public.

Ms. Jere Fredenburgh addressed the Board on the possibility of establishing an advisory board and an appeals board to address community development issues and give the citizens of Cochise County a voice.

Jack Cook addressed the Board on matters of personal concern.

Chairman English closed the Call to the Public.

Fleet

10. Approve the renewal of Contract 11-34-HFM-04 for Heavy Equipment Rentals to various vendors in the not to exceed amount of \$96,000 for the period of April 1, 2013 through March 31, 2014 for the Fleet Management Department.

Vice-Chairman Searle made a motion to approve items 1-10 of the Consent Agenda. Supervisor Call seconded the motion and it carried unanimously 3-0.

PUBLIC HEARINGS**Board of Supervisors**

11. Approve the Cable Television License Agreement with Cox Cable effective August 3, 2014 through August 2, 2029.

Supervisor Call requested that the item be tabled so that more information could be obtained regarding the details of the agreement.

Mr. Hanson suggested opening the public hearing since it was noticed for today and stated that posting another public notice would not be necessary if the item was tabled to a time certain.

Chairman English opened the public hearing.

Mr. Michael Stull, Cox Communications representative, said that he had been working with County staff over the last year on this agreement and explained that the reason a new agreement had to be approved was to comply with new changes to state law. He noted that he would be available at the special meeting to answer any questions from the Board.

Supervisor Call moved to table the item to a special meeting to be held on May 7, 2013 at 11:00 a.m. Vice-Chairman Searle seconded the motion and it carried unanimously 3-0.

Facilities

12. Adopt Resolution 13-11 authorizing the submission of application(s) for FY 2013 State Community Development Block Grant Funds.

This item was presented by Ms. Lisa Marra, Grants Administrator, using a PowerPoint presentation. Ms. Marra reviewed the background information and stated that there were three projects that were of high priority and clarified that the County could submit up to three projects. She described and went over the total costs associated with each project: 1) Emergency Home Repair Program, \$144,080; 2) Elfrida Water District Improvements, \$120,000; and 3) Bowie Water District Improvements, \$117,000.

Supervisor Call asked about the possibility of the County paying for administrative costs so that the maximum amount of money would be used toward the projects.

Mr. Ortega said this could be done, but noted it would decrease the amount of money going into the general fund.

Vice-Chairman Searle asked when the projects were due and asked if a project from St. David could still be submitted.

Ms. Marra stated that they were due to the Southeast Arizona Governments Organization (SEAGO) by May 1, 2013 and said she had already reviewed the project from St. David and it was not eligible per federal government regulations.

Chairman English opened the public hearing.

Mr. Michael Coyle Jr. discussed the current condition of the Elfrida Water District and hoped the Board would consider their request so that the citizens of Elfrida would continue to be served.

Ms. Jere Fredenburgh said that she supported Elfrida's request.

Chairman English closed the public hearing.

Chairman English said that although the Emergency Home Repair Project would help citizens in the County, only five families would benefit as opposed to the 1,000 residents that would benefit from funding the Elfrida and Bowie Water District Improvements.

The Board discussed the breakdown of the 2 water projects.

Vice-Chairman Searle moved to adopt Resolution 13-11 authorizing the submission of application(s) for FY 2013 State Community Development Block Grant Funds for receipt and use of these funds in the following order of priority:

- i) Elfrida Water District: a) 50 gallon tank, \$72,000; b) clean/deepen existing well, \$23,000;
- ii) Bowie Water District: a) hydrants/meters, \$20,000; b) replace pump, \$28,000; c) electrical repairs, \$18,000;
- iii) Cochise County for Administrative Funds, any funds remaining, up to 18% of the total grant amount.

Supervisor Call seconded the motion.

Chairman English called for the vote and it carried unanimously 3-0.

ACTION

Community Development

13. Approve an increase in the not to exceed dollar amount of Contract No. 10-66-HFP-04 with Western Emulsions, Inc. for CRS-2 and CRS-2P emulsified asphalt products from \$1,350,000 to \$2,050,000.

Mr. Ortega stated that due to unforeseen projects the original amount had to be amended and assured the Board that this would be addressed during the normal budget discussions in the future.

Ms. Karen Riggs, Interim Director, Community Development said that there were a couple of projects last fiscal year that were not complete due to utility issues and explained that although the money rolls over, the contracts have to be redone.

Supervisor Call moved to approve an increase in the not to exceed dollar amount of Contract No. 10-66-HFP-04 with Western Emulsions, Inc. for CRS-2 and CRS-2P emulsified asphalt products from \$1,350,000 to \$2,050,000. Vice-Chairman Searle seconded the motion.

Chairman English called for the vote and it carried unanimously 3-0.

Indigent Defense

14. Approve the transfer of funds in the amount of \$280,000 from General Fund Contingency Account to Indigent Defense Coordinator (IDC) budget accounts.

This item was presented by Mr. Mike Ortega, County Administrator. Mr. Ortega said that although he budgeted \$1,000,000 for the three capital cases the County was responsible for he put the money in general fund contingency therefore the Board should approve the transfer of funds from general fund contingency to indigent defense coordinator account. He stated that the costs for the three cases had not come close to the funds allocated, but one case was still pending and there would be ongoing costs associated with the pending case. He said that the final cost of all three cases would not be known until the third case was finalized.

Vice-Chairman Searle moved to approve the transfer of funds in the amount of \$280,000 from General Fund Contingency Account to Indigent Defense Coordinator (IDC) budget accounts. Supervisor Call seconded the motion.

Chairman English called for the vote and it carried unanimously 3-0.

STATE & FEDERAL LEGISLATION

15. Discussion and possible action regarding state and federal legislative matters, including but not limited to the items in the attached County Supervisors Association Legislative Policy Committee Agenda, the proposed State budget.
