

**PROCEEDINGS OF THE COCHISE COUNTY BOARD OF SUPERVISORS
REGULAR BOARD MEETING HELD ON
TUESDAY, JULY 9, 2013**

A regular board meeting of the Cochise County Board of Supervisors was held on Tuesday, July 9, 2013 at 10:00 a.m. in the Board of Supervisors' Hearing Room, 1415 Melody Lane, Building G, Bisbee, Arizona. In attendance were Ann English, Chairman; Richard Searle, Vice-Chairman; Patrick Call, Supervisor; Michael Ortega, County Administrator; Jim Vlahovich, Deputy County Administrator; Adam Ambrose, Civil Deputy County Attorney; and Arlethe Rios, Assistant to the Clerk of the Board.

Chairman English called the meeting to order at 10:00 a.m.

1. Adopt Resolution 13-20 to partner with the Commemorative Partner Program with the Arizona Department of Veterans Services that will recognize, thank and honor our Vietnam Veterans and their families.

Vice-Chairman Searle made a motion to approve items 1-16 of the Consent Agenda. Supervisor Call seconded the motion and it carried unanimously.

Board of Supervisors

17. Approve a new liquor license application for a series #13 (domestic farm winery) liquor license submitted by Ms. Kimberly B. Asmundson for Asmundson Family Vineyard located at 6701 S. Zarpara Lane in Willcox, 85643.

Ms. Arlethe Rios, Assistant to the Clerk of the Board presented this item. Ms. Rios said the Sheriff's Office and Planning and Zoning Department have recommended approval and the Environmental Health Division noted that the establishment meets all the requirements set forth by the Arizona Food Code; the Treasurer's Office has noted that all property taxes are current. The applicant has paid the \$100 processing fee; the Board staff recommended approval.

Chairman English opened the public hearing.

No one chose to speak and Chairman English closed the public hearing.

Supervisor Call moved to approve a new liquor license application for a series #13 (domestic farm winery) liquor license submitted by Ms. Kimberly B. Asmundson for Asmundson Family Vineyard located at 6701 S. Zarpara Lane in Willcox, 85643. Vice-Chairman Searle seconded the motion.

Chairman English called for the vote and it carried 3-0.

18. Approve a new liquor license application for a series #13 (Golden Rule Vineyards) liquor license submitted by Mr. James Graham located at 3525 N. Golden Rule Road, Cochise, AZ 85606.

Ms. Arlethe Rios, Assistant to the Clerk of the Board presented this item. Ms. Rios said the Sheriff's Office and Planning and Zoning Department have recommended approval and the Environmental Health Division noted that the establishment meets all the requirements set forth by the Arizona Food Code; the Treasurer's Office has noted that all property taxes are current. The applicant has paid the \$100 processing fee; the Board staff recommended approval.

Chairman English opened the public hearing.

No one chose to speak and Chairman English closed the public hearing.

Vice-Chairman Searle noted that a new license had to be applied for because series 13 liquor licenses are not transferable.

Vice-Chairman Searle moved to approve a new liquor license application for a series #13 (Golden Rule Vineyards) liquor license submitted by Mr. James Graham located at 3525 N. Golden Rule Road, Cochise, AZ 85606. Supervisor Call seconded the motion.

Chairman English called for the vote and it carried 3-0.

Community Development

19. Adopt Zoning Ordinance 13-03, approving Docket Z-97-06A, conditionally amending the zoning district designation for parcel 121-03-005 from MH-36 to R-36, pursuant to the request of Ms. Patricia Cooper.

Mr. Peter Gardner, Planner I, presented this item using a PowerPoint presentation. Mr. Gardner discussed the background, showed the map of the location and explained the reason why the applicant wanted to abandon the property. He stated that there had not been any objections and that staff recommended approval.

Chairman English opened the public hearing.

No one chose to speak and Chairman English closed the public hearing.

Mr. Gardner said there would be no conditions for this abandonment.

Supervisor Call moved to adopt Zoning Ordinance 13-03, approving Docket Z-97-06A, conditionally amending the zoning district designation for parcel 121-03-005 from MH-36 to R-36, pursuant to the request of Ms. Patricia Cooper. Vice-Chairman Searle seconded the motion.

Chairman English called for the vote and it carried 3-0.

Solid Waste

20. Adopt Resolution 13-21 authorizing a \$1.50 increase to the Solid Waste rate for Fiscal Year 2013-14 from \$52.00 to \$53.50 per ton tipping fee, effective August 9, 2013.

Mr. Marty Haverty, Director of Solid Waste Management, presented this item. Mr. Haverty said that the reason for the increase was to increase revenues by \$100,000, that there had not been any objections by the public, and noted that the Rate Review and Advisory Board (RRAB) recommended approval.

Mr. Hanson noted that since the next three items were related the Board had the option to discuss them all at the same time.

Vice-Chairman Searle chose to keep them separate.

Chairman English asked if this would help pay for the new scales.

Mr. Haverty stated that the monies would cover any short coming in the general budget, not just the scales. He noted that recycling was down by 5% and volumes of trash were down by 15%.

Mr. Ortega commented on the reduction in trash coming into the county which will impact revenues. He also stated that the RRAB wanted to make sure that we have enough revenues to keep the system efficient and give citizens the best service possible.

Chairman English opened the public hearing.

No one chose to speak and Chairman English closed the public hearing.

Vice-Chairman Searle moved to adopt Resolution 13-21 authorizing a \$1.50 increase to the Solid Waste rate from \$52.00 to \$53.50 per ton tipping fee, effective August 9, 2013. Supervisor Call seconded the motion.

Chairman English called for the vote and it carried 3-0.

21. Adopt Resolution 13-22 authorizing a \$1.00 increase to the Rural Transfer Station Solid Waste rate for Fiscal Year 2013-14, effective August 9, 2013.

Mr. Marty Haverty, Director of Solid Waste Management, presented this item. Mr. Haverty said the County is subsidizing rural transfer stations and the raise in fees would help offset the loss of rural transfer stations. He stated that an estimate of 2,500 tons came in from rural transfer stations with revenues of \$100,000 and noted that the increase would only bring in \$30,000.

Chairman English opened the public hearing.

No one chose to speak and Chairman English closed the public hearing.

Vice-Chairman Searle said he wanted to table the item to get more information on fixed and transportation costs.

Supervisor Call moved to table the item to July 15th. Vice-Chairman Searle seconded the motion.

Chairman English called for the vote and it carried 3-0.

22. Adopt Resolution 13-23 authorizing a change in the method of calculating fees from volume based to weight based fees at the Urban Transfer Stations and the Western Regional Landfill for Fiscal Year 2013-2014, effective August 9, 2013.

Mr. Marty Haverty, Director of Solid Waste Management, presented this item. He said that the RRAB had recommended approval and that having scales at the entrance and exit would help staff have more accurate numbers.

Supervisor Call asked that the public be notified of this change.

Chairman English opened the public hearing.

No one chose to speak and Chairman English closed the public hearing.

Vice-Chairman Searle moved to adopt Resolution 13-23 authorizing a change in the method of calculating fees from volume based to weight based fees at the Urban Transfer Stations and the Western Regional Landfill effective August 9, 2013. Supervisor Call seconded the motion.

Chairman English called for the vote and it carried 3-0.

23. Adopt Resolution 13-24 authorizing a \$17.00 per ton decrease to the Solid Waste rate for Fiscal Year 2013-2014 for commercial haulers disposing of over 2,500 tons of refuse at the Western Regional Landfill, effective August 9, 2013.

Mr. Marty Haverty, Director of Solid Waste Management, presented this item. Mr. Haverty said lowering the costs would help bring in more revenue and it was an incentive for commercial businesses in the area as well as the cities.

Mr. Ortega noted that this was also recommended by the RRAB.

Chairman English opened the public hearing.

No one chose to speak and Chairman English closed the public hearing.

Supervisor Call moved to adopt Resolution 13-24 authorizing a \$17.00 per ton decrease to the Solid Waste rate for commercial haulers disposing of over 2,500 tons of refuse at the Western Regional Landfill, effective August 9, 2013. Vice-Chairman Searle seconded the motion.

Chairman English called for the vote and it carried 3-0.

Chairman English gave the Vice-Chairman Searle the responsibilities of the Chair for the rest of the meeting since she had to depart to attend another meeting.

ACTION

Community Development

24. Approve a building permit fee waiver request in the amount of \$1,172.00 for the Town of Huachuca City for the Camp Naco restoration project located at 2118 W. Newell St. in Naco.

Mr. Rick Corley, Zoning Administrator, Community Development, presented this item. Mr. Corley explained background and said that the applicant was granted a waiver in 2010. He stated that this was an ongoing restoration project and that staff recommended approval.

Supervisor Call moved to approve a building permit fee waiver request in the amount of \$1,172.00 for the Town of Huachuca City for the Camp Naco restoration project located at 2118 W. Newell St. in Naco. Vice-Chairman Searle seconded the motion.

Vice-Chairman Searle called for the vote and it carried 2-0 (English absent).

Facilities

25. Approve the award of Request for Qualifications (RFQ) No. 13-23-FAC-01 for Airport Planning and Engineering Services to Armstrong Consultants, Inc. for a three year period beginning July 1, 2013 with the option to renew the contract for two one-year periods.

Mr. Dave Seward, Procurement Director, presented this item. Mr. Seward explained the process and stated that after reviewing all bids the panel thought that Armstrong was the most qualified company.

Vice-Chairman Searle asked what the costs were covering.

Ms. Marra said that costs were not just for the plan, but also covered other projects and helped the County deal with issues regarding policies from the Federal Flight Administration and the Arizona Department of Transportation.

Supervisor Call moved to approve the award of Request for Qualifications (RFQ) No. 13-23-FAC-01 for Airport Planning and Engineering Services to Armstrong Consultants, Inc. for a three year period beginning July 1, 2013 with the option to renew the contract for two one-year periods. Vice-Chairman Searle seconded the motion.

Vice-Chairman Searle called for the vote and it carried 2-0 (English absent).

Finance

26. Approve a 0.4% increase for all Arizona State Retirement System (ASRS) covered employees effective 6/23/13.

Mr. Michael Ortega, County Administrator, presented this item. Mr. Ortega said that this was a follow up action to work session held on the budget. He explained that in order for employees not to see a decrease in their net pay this had to be approved before the tentative budget.

Supervisor Call moved to approve a 0.4% salary increase for all Arizona State Retirement System (ASRS) covered employees effective 6/23/13. Vice-Chairman Searle seconded the motion.

Vice-Chairman Searle called for the vote and it carried 2-0 (English absent).

REPORT BY MICHAEL J. ORTEGA, COUNTY ADMINISTRATOR -- RECENT AND PENDING COUNTY MATTERS

Mr. Ortega said he would be on the panel for the adult probation chief interviews and asked the Board to provide any input. He also noted that the tentative budget meeting would be held next week and he would have a presentation for the Board to explain any changes.
