

**PROCEEDINGS OF THE COCHISE COUNTY BOARD OF SUPERVISORS
REGULAR BOARD MEETING HELD ON
TUESDAY, OCTOBER 8, 2013**

A regular board meeting of the Cochise County Board of Supervisors was held on Tuesday, October 8, 2013 at 10:00 a.m. in the Board of Supervisors' Hearing Room, 1415 Melody Lane, Building G, Bisbee, Arizona. In attendance were Ann English, Chairman and Patrick Call, Supervisor; Michael Ortega, County Administrator, Britt Hanson, Chief Civil Deputy County Attorney; and Arlethe Rios, Clerk of the Board.

Chairman English called the meeting to order at 10:00 a.m.

PLEDGE OF ALLEGIENCE

ROLL CALL – Chairman English and Supervisor Call were present; Vice-Chairman Searle was absent.

CALL TO THE PUBLIC

Chairman English opened the Call to the Public.

Mr. Jack Cook addressed the Board on matters of personal concern.

No one else chose to speak and Chairman English closed the Call to the Public.

8. Approve the award of Invitation for Bids (IFB) No. 14-07-FMD-04 to American Equipment & Trailer Inc. for the purchase of two Walking Floor Transfer Trailers for the Fleet Management/Solid Waste Department in the amount of \$131,330 plus applicable tax.

9. Approve the renewal of Contract No. 10-18-PUR-02 for Countywide Printing Services to West Press, for the period of October 1, 2013 through September 30, 2014.

Health

10. Approve the Medical Group Participation Agreement between Cochise County and United Healthcare for a period of three years that can be automatically renewed for subsequent one-year periods.

Mr. Ray Falkenberg, Administrative Services Manager presented this item. Mr. Falkenberg stated that United Healthcare was granted the AHCCCS grant and therefore the County had to have an agreement with them in order to bill them for any AHCCCS costs.

Supervisor Call moved to approve the Medical Group Participation Agreement between Cochise County and United Healthcare for a period of three years that can be automatically renewed for subsequent one-year periods. Chairman English seconded the motion.

Chairman English called for the vote and it carried 2-0.

11. Approve Intergovernmental Agreement (IGA) ADHS14-053682, Maternal, Infant & Early Childhood Home Visiting (MIECHV), between the Arizona Department of Health Services (ADHS) and Cochise Health & Social Services (CHSS) in the amount of \$102,000 annually, for the period 07/01/13 – 09/30/15.

Ms. Judith Gilligan, Prevention Services Director, presented this item. Ms. Gilligan addressed both items 11 and 12 since they were related. She gave the background for both IGAs and said that the group receiving the funding had already been getting together and addressing issues in the region as well as streamlining a lot of processes to help families. She added that the grant monies would help this group attend trainings and expand services. Ms. Gilligan explained that a sub contract was needed because the State would not contract directly with Child & Family Resources Inc.

Supervisor Call moved to approve Intergovernmental Agreement (IGA) ADHS14-053682, Maternal, Infant & Early Childhood Home Visiting (MIECHV), between the Arizona Department of Health Services (ADHS) and Cochise Health & Social Services (CHSS) in the amount of \$102,000 annually, for the period 07/01/13 – 09/30/15. Chairman English seconded the motion.

Chairman English called for the vote and it carried 2-0.

12. Approve Inter-Agency Subcontract Agreement 13-46-HEA-01, Maternal, Infant & Early Childhood Home Visiting Program, between Cochise Health & Social Services (CHSS) and Child & Family Resources, Inc. (CFR), in the amount of \$97,751 to CFR for the period 10/01/13 – 09/30/15, renewable annually.

Ms. Judith Gilligan, Prevention Services Director, addressed this item in conjunction with item 11.

Supervisor Call moved to approve Inter-Agency Subcontract Agreement 13-46-HEA-01, Maternal, Infant & Early Childhood Home Visiting Program, between Cochise Health & Social Services (CHSS) and Child & Family Resources, Inc. (CFR), in the amount of \$97,751 to CFR for the period 10/01/13 – 09/30/15, renewable annually. Chairman English seconded the motion.

Chairman English called for the vote and it carried 2-0.
