## Health Start Program

Effective July 1, 2017, it is mutually agreed that the Contract referenced is amended as follows:

1. The Annual Health Services Projection Form of the Contract is revised as attached in this Amendment One (1) to reflect the increase of unit rates but decrease of frequency in services. The Contract budget total increased from \$306,180 to **\$306,185**. The line item pricing shall be revised in ProcureAZ to align with available funding upon execution of this Amendment One (1).
2. Pursuant to Uniform Terms and Conditions, Provision Five (5), Contract Changes, Item 5.1 Amendments, Provision Twenty-Five (25) is added to the Special Terms and Conditions to read as follows:

### **25. Contracting; Procurement; Investment; Prohibitions**

- 25.1 A public entity may not enter into a contract with a company to acquire or dispose of services, supplies, information technology or construction unless the contract includes a written certification that the company is not currently engaged in, and agrees for the duration of the contract to not engage in, a boycott of Israel.
- 25.2 A public entity may not adopt a procurement, investment or other policy that has the effect of inducing or requiring a person or company to boycott Israel.

**All other provisions shall remain in their entirety.**

Contractor hereby acknowledges receipt and acceptance of above amendment and that a signed copy must be filed with the Procurement Office before the effective date.
